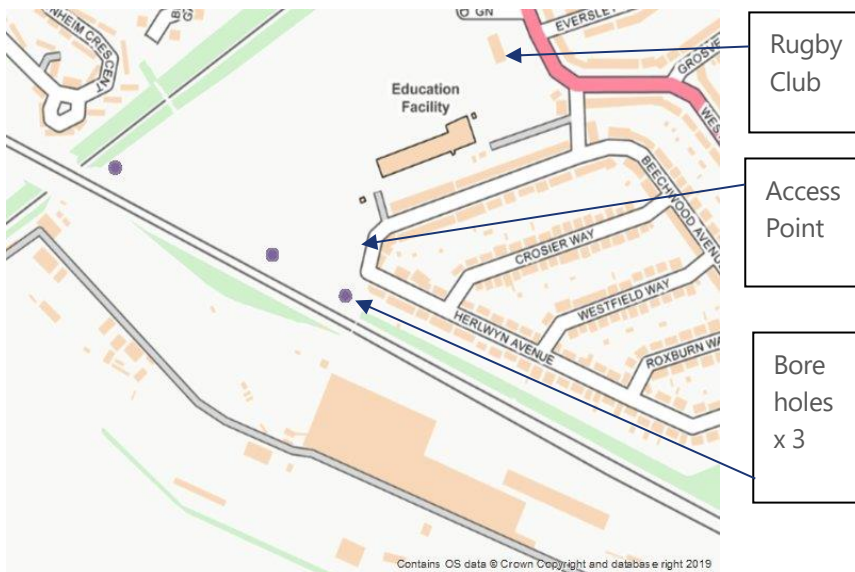
Ground Investigations at Ruislip Rugby Club

High Speed Two (HS2) is the new high speed railway for Britain. As part of developing the route design of the HS2 high-speed railway we are carrying out further ground investigation surveys in your area. The results will build on the information we already have from work done in 2017, helping us get a better understanding of the ground conditions.

What are we doing.

We will be carrying out ground investigations work next to the railway line in the grounds of Ruislip Rugby Football Club, from the 6 January for a period of up to four weeks. This will involve drilling down to retrieve a small core of ground from three areas in the approximate locations shown below.



The site will be surrounded by protective barriers and acoustic screens to reduce any site noise. We will undertake the work in the smallest areas possible to reduce any disruption. In addition, there will be a small amount of geophysical data collection but this will be low impact and creates no noise. We will avoid working on Saturdays as we have discussed with the club the activities that happen on each of the weekends. We will keep you informed about any changes.

Duration of works

From week beginning 6 January for up to four weeks

Working hours are from 8am to 6pm Mondays to Fridays.

We may need to be on site for an hour before the start and/or end of each shift

What to expect

Sites will be secured with barriers and acoustic screens to reduce noise

Drilling Equipment and mobile units will be on site

As part of the testing activity a generator might need to run for periods
