

Notice of hoarding work along Network Rail border

High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within the guidelines are operational. All sites will remain under constant review.

We have postponed all face-to-face engagement events and meetings and have put in place a number of channels to communicate with communities, such as letters and phone calls, as well as updates and alerts from each of the local community websites. You can sign up for regular updates in your local area at www.hs2inhillindon.co.uk.

What we are doing

The work being undertaken will take place for 20 days and nights from the 8 June, however the night time work will be between 1am and 5am when no trains are running.

SCS will fit wooden hoarding along the Network Rail boundary to the south of the work compound to ensure that the site is both safe and secure. This work will take place during the day.

Night time works will take place on Network Rail land as this is the only time the Chiltern line has no trains running. This night time work will be to remove the metal palisade fencing, placement of wooden posts into a concrete base and then placement of wooden hoarding.

The side of the hoarding facing the properties in The Greenway and Hoylake Crescent will be painted a dark blue. This colour has been agreed with Network Rail who need to ensure that the red, amber, and green lights are visible to their driver's sight lines.

There will be a period where SCS will remove part of the existing railway cutting. This will be behind the new hoarding and will be done during the day. You will see where the hoarding line is on the map overleaf.

Duration of works

These works will begin on the 8 June and will run continuously for 20 days and nights.

Day time work will take place between 8am and 6pm.

Night time work will take place between 1am and 5am when no trains are running.

SCS may be on site for up to an hour before and after these hours to allow for preparation.

What to expect

Removal of palisade fencing will be by hand tools to keep noise to a minimum.

Placement of the posts will require a digger to expose the ground and place the posts. All other activity will be using hand tools to keep noise to a minimum.

What we will do

All activity we undertake will be COVID compliant.
