







# Notice of works next to old ARLA site

High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within the guidelines are operational. All sites will remain under constant review.

We have postponed all face-to-face engagement events and meetings and have put in place a number of channels to communicate with communities, such as letters and phone calls, as well as updates and alerts from each of the local community websites.

As part of the preconditioning surveys for the HS2 high-speed railway we are carrying out monitoring to the rail system in your area.

#### What are we doing?

We will be placing some battery powered monitoring equipment onto sleepers within the area shown below as well as solar powered monitoring equipment on short poles which will monitor to ensure our construction near the lines cause no issues at all. As all the equipment is self-powered there will be no need for any wires or cables to be placed in the area.

Works will comply with all safety rules with regard to working within the rail and tube environment. This being the case the work will take place during the hours shown on the blue panel. We will only use hand tools so the noise from the works will be minimal. To sign up for news alerts please visit the website above.

#### **Duration of works**

The work will take place on the night/early morning of 3 May

Working hours will be from midnight to 8am

We may be on site for an hour before and/or end of each shift

This work is taking place during a rail possession

Only hand tools will be used during this work.

Access to the area of work will be via the Network Rail access from Long Drive

#### What we will do

There will be no interference to any of your utility services during this activity

We will leave this equipment in for the duration of works at the ARLA site


