High Speed Two (HS2) is the new high speed railway for Britain. From 6 January we will be carrying out utility surveys in your area. The surveys will help us understand the condition and location of utility services and how best to protect them while we are building HS2.

### What we are doing – Ground Penetrating Radar

We will be carrying out utility surveys in the West End Road area for a short period in the next three months. First, we will put small studs on the ground to set up the survey area. Then scanning equipment will be used to create a map of the utility services below the ground and then they will be marked using biodegradable spray paint. We will use cameras to take site photos of the completed work.

# What we are doing – CCTV Surveys of the sewer systems

We will also be carrying out surveys to investigate the condition of the drainage. Should we find a blockage we may need to flush the drainage system with a high-pressure water jet to carry out our investigations.

### How this might affect you

A temporary lane closure will be needed for a very short period to protect staff carrying out the surveys. Some of the surveys will take place in the footway. You will still be able to travel and walk through the area but may be asked to wait for a short time. Your utility services will not be affected during the surveys

If any parking restrictions are needed it will be indicated on street furniture in the week before activity begins

### **Duration of works**

From 6 January the works will take place for a short period within a three month window

The stud work will happen during the day then the surveys will happen at night

### What to expect

Monday to Fridays 8pm to 6am (although the stud work in preparation will happen during the day)

We may be on site for an hour before the start and/or the end of the shift. Please note that these works are very short in duration

Survey equipment includes tripods and trolley mounted vehicles. A jetting lorry and drainage survey van will be present for the CCTV surveys should a blockage be found

We will provide access to your property at all times


