High Speed Two (HS2) is the new high speed railway for Britain.


We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within the guidelines are operational. All sites will remain under constant review.

We have postponed all face-to-face engagement events and meetings and have put in place a number of channels to communicate with communities, such as letters and phone calls, as well as updates and alerts from each of the local community websites.

What we are doing

Firstly, we walk over the area with ground penetrating radar to identify utilities in the area around the Ramada Hotel. From that survey, we will create a map of all the utilities. Once that is complete we will carry out more intrusive surveys into the ground at the side of the building to fully understand the foundations. There will be some noise during the hours listed so we will surround the works with barriers and acoustic screening. The approximate location of works is shown below:

Duration of works

These works will start on the 4 May and last for two weeks

Working hours will be 8am to 6pm Monday to Friday and 8am to 1pm on Saturday if it is required.

Operatives may be on site for up to an hour before/after the hours shown.

What to expect

Ground radar will look like a lawnmower sized machine operated by an individual.

Foundations work will have a drilling machine

There will be some noise during the times shown

Site will be secured with barriers and screens to reduce the noise

Generator may need to run for periods during the works
