# Notice of lane closure on Harvil Road for surveys

High Speed Two (HS2) is the new high speed railway for Britain.

## **Being COVID-19 Compliant**

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within the guidelines are operational. All sites will remain under constant review.

We have postponed all face-to-face engagement events and meetings and have put in place a number of channels to communicate with communities, such as letters and phone calls, as well as updates and alerts from each of the local community websites. ## What we are doing

We are carrying out a CCTV survey on a small piece of Harvil Road (shown on the map overleaf) to check upon the condition of the sewer. Should we find a blockage we may need to flush the drainage system with a high-pressure water jet to carry out our investigations.

# How might this affect you

A temporary single lane closure will be in place for a very short period to protect staff carrying out the surveys. You will still be able to travel through the area but may be asked to wait for a short time.

Utility services will not be affected during the surveys.

The work will take place between 9am and 3.30pm on the Thursday and Friday

## What to expect

A small robot with a CCTV camera on board will be placed in the sewers so that we can carry out the survey.

A jetting lorry and drainage vehicle will be on standby should we need to clear an obstruction

These surveys are of a very short duration

Traffic Management will be taken down as soon as we no longer need it.


