

# Notice of lane closure in Harvil Road

High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within the guidelines are operational. All sites will remain under constant review.

We have postponed all face-to-face engagement events and meetings and have put in place a number of channels to communicate with communities, such as letters and phone calls, as well as updates and alerts from each of the local community websites. ## What we are doing

We are starting to work on the building of a new section of Harvil Road, with a new bridge over the Chiltern railway line. We will erect hoarding along the east side of Harvil Road, just south of the Chiltern Line Bridge and opposite Skip Lane, which will allow for the expansion of our works area without being a distraction to the road users.

To build this hoarding our operatives will need to work in the road and, for the safety of the staff, we will need to close the southbound lane. To keep the closure as small as possible we will only close the lane where works are happening. This means that we will close the road in three phases (moving south to north) over the dates shown on the blue panel and on the maps shown overleaf.

We will have traffic lights signals controlling the lane closure for vehicle traffic. We will also maintain pedestrian lights at the locations where the footways cross the road.

### Duration of works

These works will take place between 13<sup>th</sup> July and 7<sup>th</sup> August.

Our work will happen between 8am and 6pm Monday to Friday.

We may be on site for an hour before and after to prepare for works.

### What to expect

The operatives will mostly use handheld tools, but there will be some larger machinery to assist with the placement of the hoarding posts.

Operatives will monitor the traffic lights whilst they are in operation.

The hoarding will be wrapped in a green ivy print to better match the surrounding area.
