We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. What we are doing

From 30 July we will be carrying out ground investigation work at the rear area of Santino's Pizzeria on Long Drive, the area is shown on the map overleaf.

We will carry out a survey using scanning equipment to identify the utilities in the area, and then we will carry out a ground investigation by drilling a borehole into the ground to identify the make-up of the ground in the area. This will better inform our design decisions in the area.

How this may affect you

You may see a small number of operatives using a device similar in size to a large lawnmower for the ground penetrating radar surveys.

A small team of operatives will drill a borehole into the ground to recover details about the ground beneath the work area shown on the map.
