Update of utility surveys on Ickenham Road

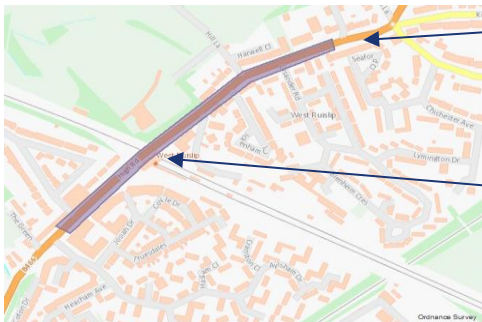
High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within the guidelines are operational. All sites will remain under constant review.

We have postponed all face-to-face engagement events and meetings and have put in place a number of channels to communicate with communities, such as letters and phone calls, as well as updates and alerts from each of the local community websites. What we are doing

We will be carrying out utility surveys on Ickenham Road from 22 to 28 May. Scanning equipment will be used to create a map of the utility services below ground using biodegradable spray paint.

How this might affect you

A temporary lane closure will be in place for a short period to protect staff carrying out the surveys. Some of the surveys will take place in the footway. You will still be able to travel and walk through the area but may be asked to wait for a short time. Your utility services will not be affected during the surveys. The dates and locations for the surveys could change and we may need to carry out further surveys in your area.

Duration of works

From 26-28 May

Working hours

Mondays to Fridays 8pm to 6am. (although the stud work in preparation will happen during the day)

We may be on site for an hour before the start and/or end of each shift

What to expect

Surveying equipment including tripods and trolley mounted or vehicle mounted equipment

Temporary traffic management will be in place

Temporary markings on the road and footway are completely harmless to the environment and will wash away

Provide access to local residences and businesses at all time
