
# **Ground Investigations** in Bridgewater Road

High Speed Two (HS2) is the new high speed railway for Britain. As part of developing the route design of the HS2 high-speed railway, we are carrying out further ground investigation surveys in your area. The results will build on the information we already have from work done in 2017, helping us get a better understanding of the ground conditions and underground building foundations.

#### What are we doing?

We will be carrying out ground investigations work next to the Railway line in Bridgewater Road Recreation Ground from 20 January for up to four weeks. This will involve drilling down to retrieve a small core of ground. The approximate location of the survey is shown below.



There will be some noise during the daylight hours listed in the panel to the right; the site will be surrounded by protective barriers and acoustic screens to reduce this. We will undertake the work in the smallest areas possible to reduce any disruption as we are aware that some people walk their dogs around this part of the grounds. These dates may change due to unforeseen circumstances. We will keep you informed about any changes.

#### **Duration of works**

From week beginning 20 January for up to four weeks

Working hours are from 8am to 6pm, Mondays to Fridays, and 8am to 1pm Saturdays if needed

We may be on site for an hour before the start and/or end of each shift

#### What to expect

Sites secured with barriers and acoustic screens to reduce noise

Drilling equipment and mobile units on site.

As part of testing activity a generator might need to run for periods during these works
