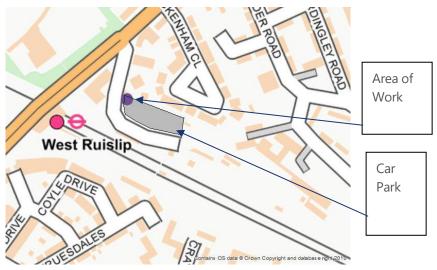
Ground Investigation works West Ruislip Station car park

High Speed Two (HS2) is the new high speed railway for Britain. As part of the developing the route design of the HS2 high-speed railway, we are carrying out further ground investigation surveys in your area. The results will build on the information we already have from works done in 2017, helping us to get a better understanding of the ground conditions in the area.

What we are doing

We will be carrying out the investigation work in the western part of the West Ruislip car park from the week commencing 13th January for a period of up to four weeks. This will involve drilling down to retrieve a small core of ground. The approximate location of the survey is shown below.



There will be some noise during the hours listed in the panel to the right. The site will be surrounded by protective barriers and acoustic screens to reduce this. We will undertake the work in the smallest areas possible to reduce any disruption. We are aware that the car park is busiest during the morning and evening rush hours and will avoid this time where possible when we are delivering to the site. These dates may change due to unfortunate circumstances. We will keep you informed about any changes.
