High Speed Two (HS2) is the new high speed railway for Britain.

Being COVID Compliant

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within the guidelines are operational. All sites will remain under constant review.

We have postponed all face-to-face engagement events and meetings and have put in place a number of channels to communicate with communities, such as letters and phone calls, as well as updates and alerts from each of the local community websites. What is happening

From 7 October we will be completing the ground strengthening works required to build the new rail bridge over Breakspear Road South. This activity involves the use of a rig placing stone columns into the earth to form part of the foundations. The use of stone rather than concrete into the earth significantly reduces the amount of spoil and the number of vehicle movements.

The equipment will be brought to the works area (shown on map overleaf) from the first of October, with the creation of the stone columns starting a week later.

Duration of works

Work in this area will begin on the 7 October and is scheduled to last for four weeks. Hours of work will be from 8am to 6pm Monday to Friday, with Saturday 8am to 1pm if required.

We are permitted to use an hour before/after the hours shown to carry out preparatory works.

What to expect

A rig is used that will push a hole into the ground. This hole will then be filled with stones fed from a large hopper.

This system allows for a fast completion of the all the foundations required in the area.
