

# Notice of utility surveys in Bridgewater Road area

High Speed Two (HS2) is the new high speed railway for Britain. From 6 January we will be carrying out utility surveys in your area. The surveys will help us understand the condition and location of utility services and how best to protect them while we are building HS2.

## What we are doing – Ground penetrating radar

We will be carrying out utility surveys on Bridgewater Road for a short period in the next three months. First, we will put small studs in the ground to set up the survey area. Then scanning equipment will be used to create a map of the utility services below ground and they will be marked using biodegradable spray paint. We will use cameras to take site photos of the work completed

## What we are doing – CCTV surveys of the sewer system

We will also be carrying out surveys to investigate the condition of the drainage. Should we find a blockage we may need to flush the drainage system with a high-pressure water jet to carry out our investigations

## How might this affect you

A temporary lane closure will be in place for a very short period to protect staff carrying out the surveys. Some of the surveys will take place on the footway. You will still be able to travel and walk through the area but may be asked to wait for a short time. Your utility services will not be affected during the surveys.

If any parking restrictions needed will be indicated on road furniture in the week before activity begins

## Duration of works

From 6 January the works will take place for a short period within the three-month window.

The stud work will happen during the day then the surveys at night

## What to expect

Monday to Fridays 8pm to 6am (although the stud work in preparation will happen during the day)

We may be on site for an hour before and/or end of the shift. Please note that these works are very short in duration

Survey equipment including tripods and trolley mounted vehicles. A jetting lorry and drainage survey van will be present for the CCTV should a blockage be found

Temporary markings on the road/footway are completely harmless to the environment and will wash away
