High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within these guidelines are operational. All sites will remain under constant review.

## Surveyor visits

On Wednesday 10 March and Wednesday 24 March 2021, our surveying team will be visiting locations between Northolt and South Ruislip to carry out surveys on and near the railway tracks.

The surveys will be carried out during a track possession while trains are not running between 1am and 5am on the above dates.

Our surveyors will use a tripod on the ground to measure angles and distances and will be using hand tools so the noise from the activity will be minimal.

Keep disruption to a minimum

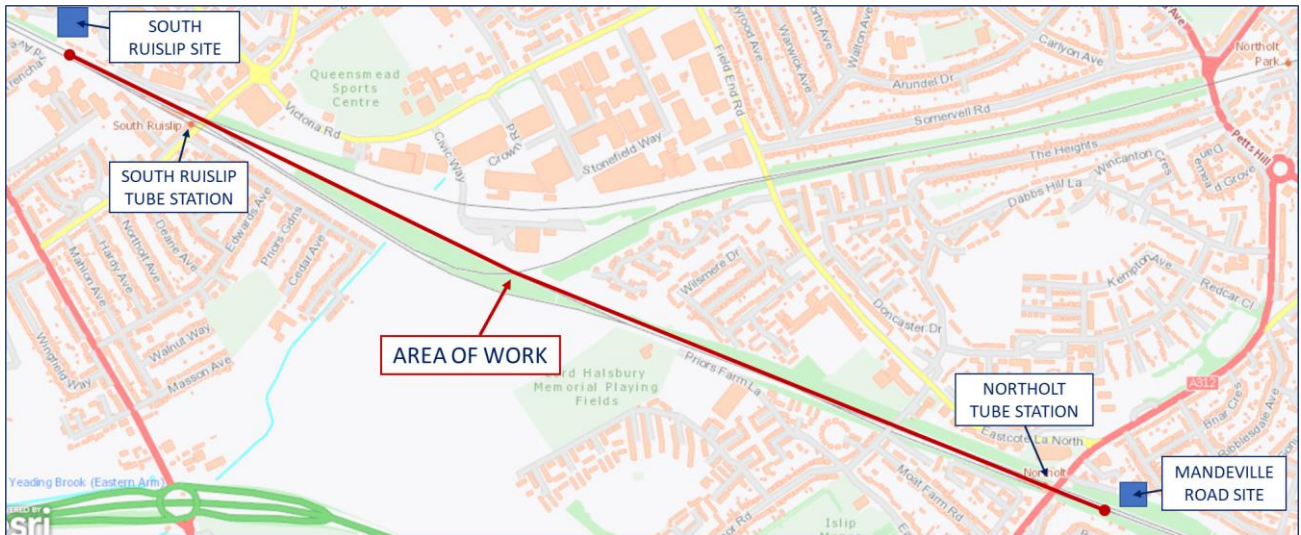
