

Notice of archaeological trial trench works

High Speed Two (HS2) is the new high speed railway for Britain. Fusion is the early works contractor on this part of the project. As part of our continued programme of surveying works in your local area we have already carried out geophysical surveys to identify areas of possible archaeological interest. The next steps of our archaeological investigation work will involve excavating trenches and recording any finds.

When will these works take place?

These works are planned to start early March 2020 and will be completed by Summer 2020.

The site for the archaeology works is located near Lower Boddington. Access to the site will be along Banbury Road and Claydon Road.

What will we be doing?

We will begin archaeological investigations in the area shown on the map. These works enable a greater understanding of archaeology in the area. This will require the excavation of a number of trial trenches. Once the work is completed, the trenches will be backfilled.

This work will be carried out by Connect, Fusion's archaeology subcontractor. The digging and investigations will be done by teams of five workers using a mechanical excavator. There will be a maximum of two teams on site and a small number of supervision staff visiting site to ensure the work is progressing to plan and is being done safely.

During the archaeological phase of investigations being carried out by Fusions contractors, there will be some opportunities for communities to find out about our work either through general community events, specific talks or visits from our specialist archaeologists. Duration of works

The works are planned to start early March 2020 until Summer 2020.

Normal working hours:

Monday to Friday 8am – 6pm.

We may also be on site for one hour's quiet start-up and shutdown outside of these times.

What to expect

Some additional traffic on local roads.

Noise from the equipment used for the works.

Site manned with 24hr security and temporary flood lighting.

Site storage and welfare vehicle.

What we will do

Manage any impacts, such as traffic and noise with the aim of reducing them.

How may this affect you?

We will be working hard to ensure any impacts on residents are kept to a minimum during these and all our future works. You may notice a little extra traffic on the road immediately around the sites with workers moving to and from the site, and occasional delivery vehicles. There may be some noise from the machinery. All machinery will be restricted to running between the hours of 8am and 6pm Monday to Friday. There may be occasional weekend working subject to local authority consent.

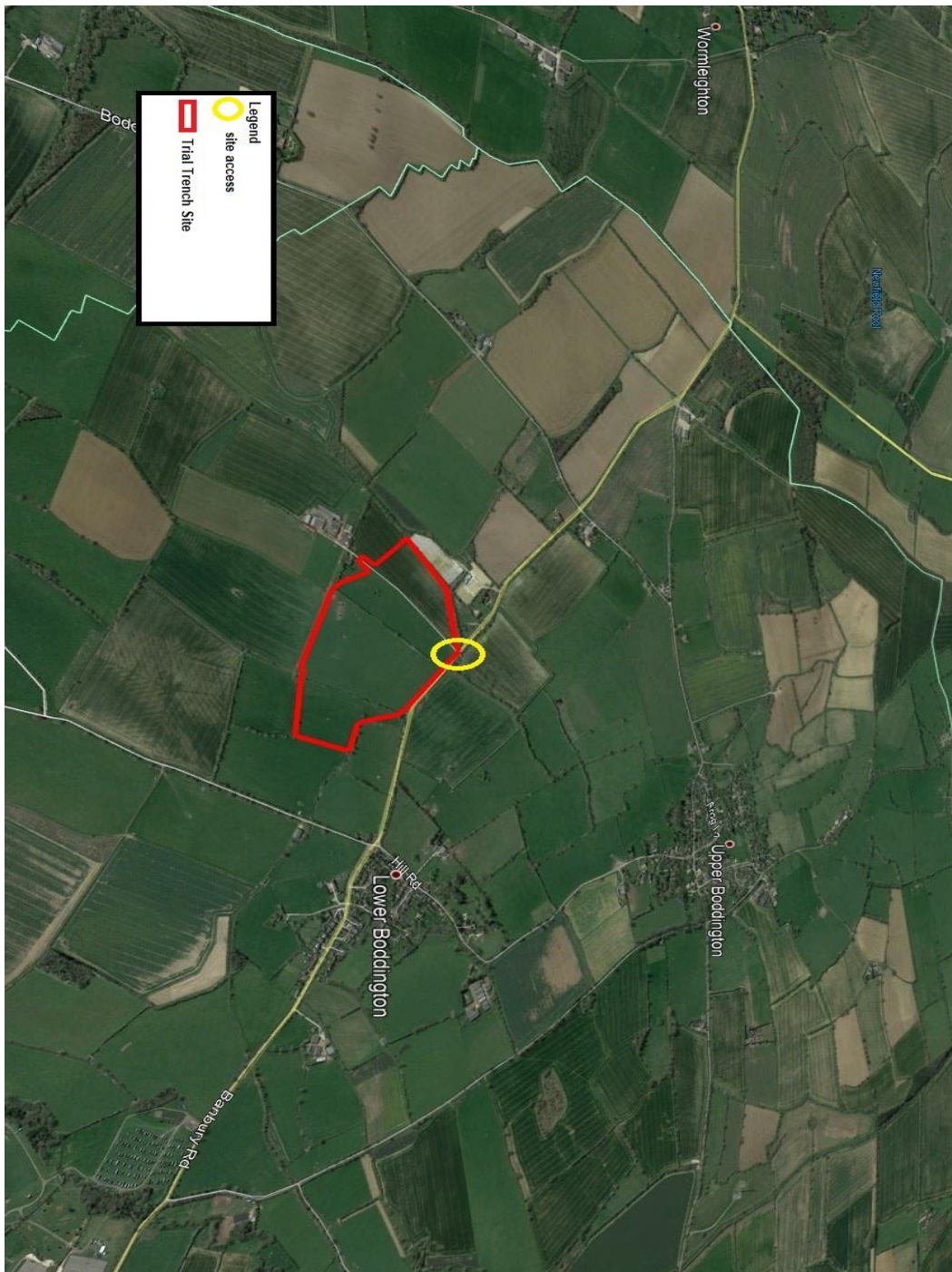
