

# Notice of rescheduled weekend closure on the B4438 to April

High Speed Two (HS2) is the new high speed railway for Britain. Early works for HS2 are being carried out by a joint venture between Laing O'Rourke and J. Murphy & Sons, known as LM. In your area, we are working near the A452, A45 and M42, which surround the site of the future HS2 Interchange Station.

# We're improving the local road network

We are remodelling and improving sections of the existing road network in the area, and creating new routes on HS2 land, which will connect to four new highway bridges. These road improvements will ensure that when the future station is operational, the local road network is fit for purpose.

Several weeks ago, we informed you that we would carry out a temporary weekend closure along a short section of the from 8pm on Friday 26 March, to 5am on Monday 29 March. **However, due to unforeseen circumstances outside of our control, this temporary weekend closure has been rescheduled.** 

### We've rescheduled our work to start on Friday 9 April

We'll carry out the rescheduled temporary weekend closure along a short section of the B4438 **from 8pm on Friday 9 April, to 5am on Monday 12 April** (see map on page 2). A signed diversion route will be in place for drivers. From 12 midnight to 2am on Monday 12 April, the closure extent and signed diversion route will change, as we work on a short section of Northway Island (see map on page 3).

### **HS2 during the coronavirus pandemic**

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with coronavirus. The Government's current coronavirus strategy makes clear that construction activity can continue as long as it complies with this guidance. Please be assured that those sites that are currently still working are doing so because they can operate within PHE and construction industry guidelines.

# Location of rescheduled weekend closure on a short section of the B4438




