



# Notice of road closure - Packington Lane

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working on behalf of HS2 Ltd to build the new high speed railway in your area.

## Ground Investigation Surveys

In July, we sent out a notification to outline the start Balfour Beatty VINCI work within the Interchange station area. Continuing with these works, we will be completing ground investigation surveys within side verges of Packington Lane. These surveys help us identify what utilities are within the area.

## When will the work take place

The surveys are due to take place over 1 night on **Friday 16<sup>th</sup> October 2020**

To complete our works in a safe environment, we will be implementing a temporary night time road closure to Packington Lane. The temporary closure will be in place from 9:00pm – 5:00am. Road signage will be in place to highlight the diversion routes. Access to residents living on Packington Lane will be maintained.

## HS2 during the COVID-19 pandemic

We are continually reviewing the works on our construction sites in line with the Government and Public Health England (PHE) advice on dealing with coronavirus. The Government's current coronavirus strategy makes clear that construction activity can continue as long as it complies with this guidance. - Our workforce to be on site 1 hour before and 1 hour after, to set up and take down equipment.

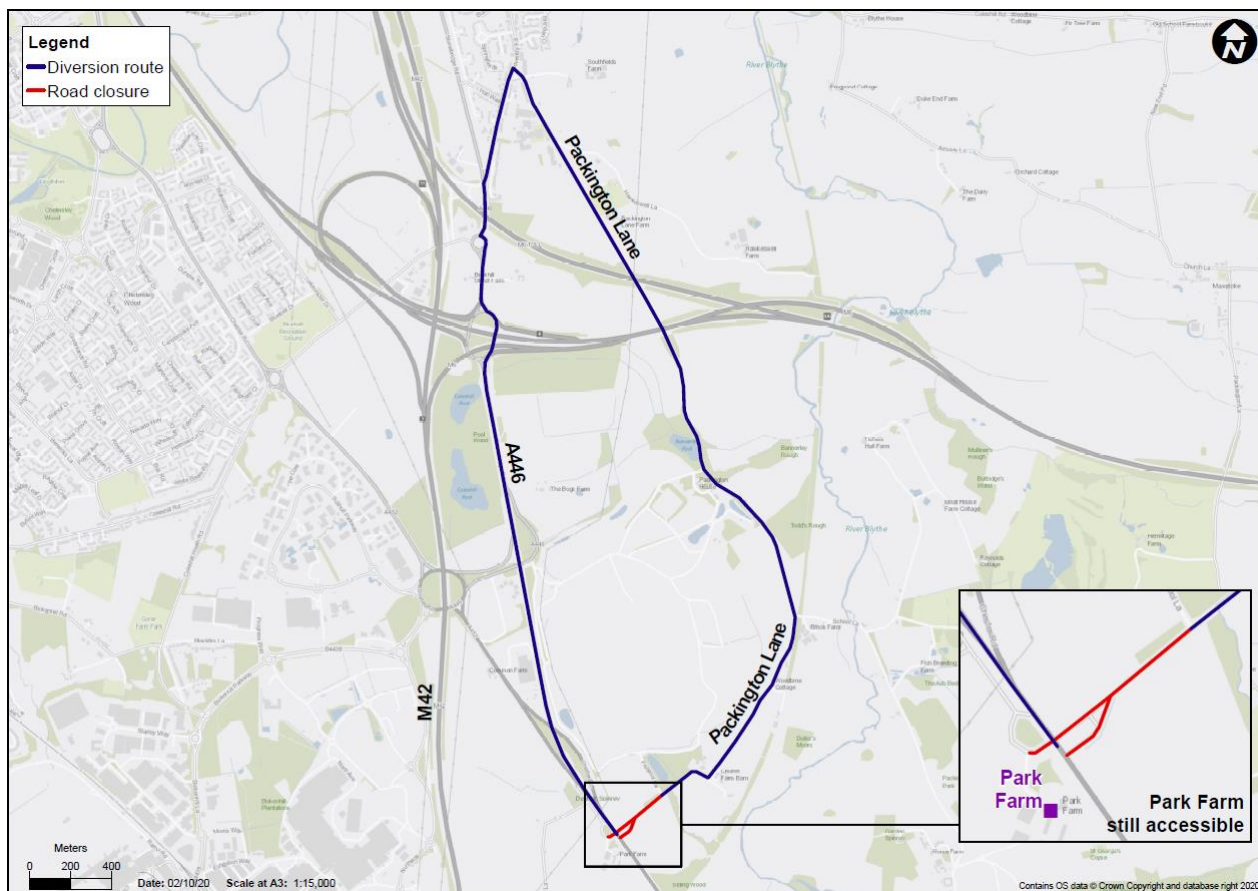
