Notification



High Speed Two (HS2) is the new high-speed railway for Britain. We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance.

Please be assured that only sites that can operate within the guidelines are operational. All sites will remain under constant review. We have postponed all face-to-face engagement events and meetings and have put in place a number of channels to communicate with communities, such as letters and phone calls, as well as updates and alerts from each of the local community websites. What will we be doing?

We will be undertaking ecological planting at the Windmill Hill site, off Ladbroke Hill Lane. The planting will comprise of hedgerow and woodland planting as well as boundary fencing to section off the new planting area. Works will commence late-February 2021 and be completed over spring 2021.

Site compound

There will be two small temporary compounds which will consist of track matting and Heras fencing with one of these sites containing a welfare unit. You can find the locations of these on the map enclosed. As the woodland species will mainly be planted by hand with machinery being used on a temporary basis no machinery will be stored on site overnight.

Duration of works

The works will start late-February 2021 and continue until Spring 2021.

Normal working hours:

Monday to Friday 8am – 6pm.

Saturday 8am - 1pm

Our contractors may also be on site for one hour's start-up and shutdown outside of these times.

What to expect

Some additional traffic on local roads.

Some noise from the equipment used for the works.

Welfare vehicle for contractors parked adjacent to the site.

What we will do

Manage any impacts, such as traffic and noise with the aim of reducing or removing them.

Mitigation planting

The mitigation planting area, once complete, will help us to achieve a net no biodiversity loss across the line of the route. The area will contain over 10,000 individual hedge and tree plants. The total planting area is approximately 2.5 hectares, which is the equivalent of approximately 3 full size football pitches.

Subject to approvals and availability, we are planting a native mix of hedges, trees and wild meadow species. The current planting mix includes:

- Hazel
- Hawthorn
- Spindle
- Crab apple
- Blackthorn
- English oak
- Dogrose
- Wych elm
- Buckthorn
- Alder buckthorn

These species have been chosen as they are native to the area. The size of the individual trees planted will be between 60-80cm in height. Planting at this height and in this season gives the plants the best chance of prospering in their new habitat.

How may this affect you?

We will be working hard to ensure any impacts on residents are kept to a minimum during these and all our future works. You may notice a little extra traffic on the road immediately around the sites with workers moving to and from the site, and occasional delivery vehicles. There may be some noise from the machinery which will be restricted to running between the hours of 8am to 6pm Monday to Friday. We may work on Saturday mornings between 8am and 1pm.

No public rights of way will be closed in association with these works.

To establish access to the site, existing temporary verge signage will be used.

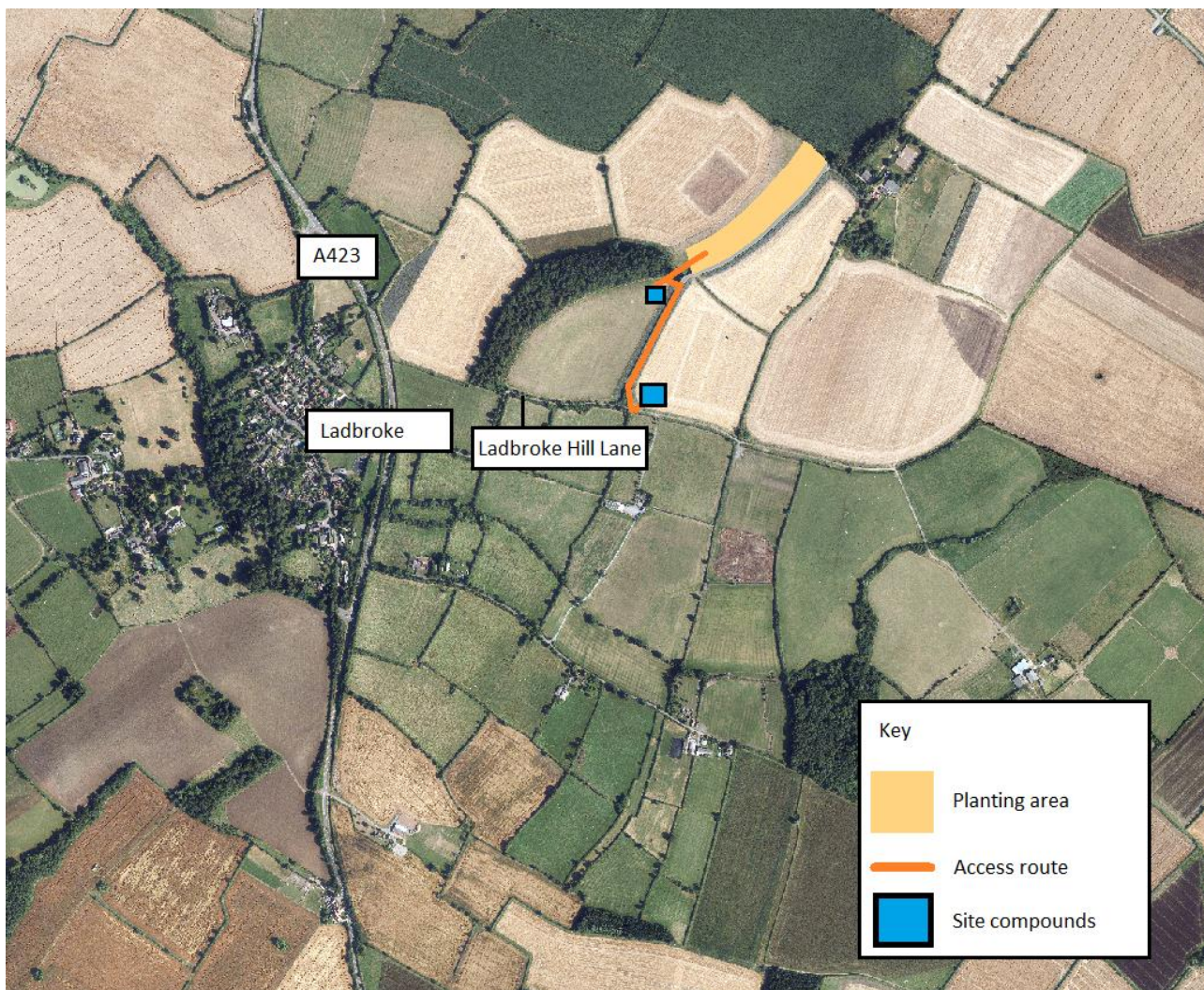
