

Notice of pipeline diversion works in Chattle hill, south of Birmingham

Road, Coleshill

High Speed Two (HS2) is the new high speed railway for Britain. Cadent will be moving underground gas pipelines in the Coleshill area, to allow for the construction of the new railway and to continue to ensure a safe and reliable gas supply.

What are we doing?

Before we start work to move the pipeline, we need to remove some vegetation on land south of Birmingham Road.

We look to avoid removing vegetation wherever possible. In this case, we cannot divert the pipeline without the removal of the vegetation.

It will also keep our workforce safe while we carry out the diversions. Appropriate ecological surveys will be undertaken prior to any vegetation clearance being carried out, and our Ecologist will be present throughout the activity to ensure there is no disruption to birds and local wildlife.

We will be accessing the works site using HS2's existing temporary works compound and access off Birmingham Road.

We will keep local people up to date as our work progresses.

How will this affect you?

There may be some noise as we carry out the work, however, this will only be for a few of hours.

The vegetation clearance will take place within our normal working hours.

Duration of works

- February 2020 until March 2020
- Our core working hours will be 8.00am to 6.00pm (Mon-Fri) and 8.00am to 1.00pm (Sat)
- We will be on-site one hour either side of these times for set-up and close-down

What to expect

- Removal of vegetation on land south of Birmingham Road, between the M6 Toll and M42.
- Increase noise for a few hours during the day
- All work will be carried out within our normal working hours.

What we will do

- Keep all sites safe and secure
- Inform people in advance of any changes


Notice of pipeline diversion works in Chattle hill, south of Birmingham Road
