



Notice of traffic management and ground investigation surveys – A46

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

There will be overnight lane and slip road closures

We will be undertaking drainage CCTV and ground investigation surveys which will help us to finalise the detailed design for this section of the route.

The ground investigation surveys will be carried out on the A46 between the Warwick Bypass junction which crosses the A452 and the Stoneleigh Road junction.

The Stoneleigh road south bound entry slip road will be closed during the works with a diversion route to the Stivichall interchange and return.

HS2 and the COVID-19 outbreak

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current COVID-19 strategy makes clear that construction activity can continue as long as it complies with this guidance. Duration of works

Traffic management will be in place from 18 – 22 January (five nights) and from 25 – 29 January (five nights)

The work, on both dates, is planned between the hours of 22:00 – 06:00.

Our workforce will be on site one hour before and after to set up and take down our work equipment.

What to expect

18 – 22 January – Lane 1 closure northbound.

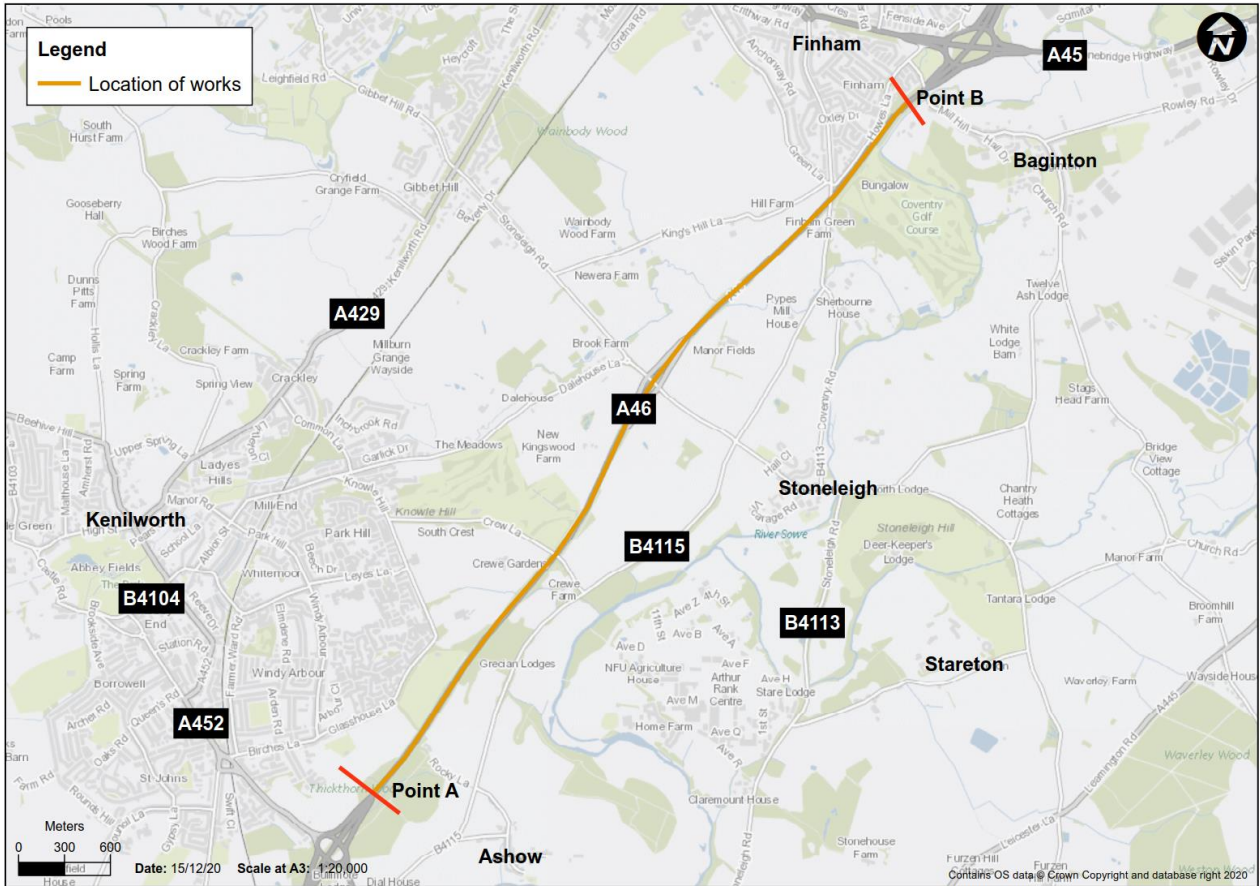
Stoneleigh Road southbound entry slip road will be closed. Diversion route will be to Stivichall Interchange and return

25 – 29 January – Lane 3 closure northbound and southbound.

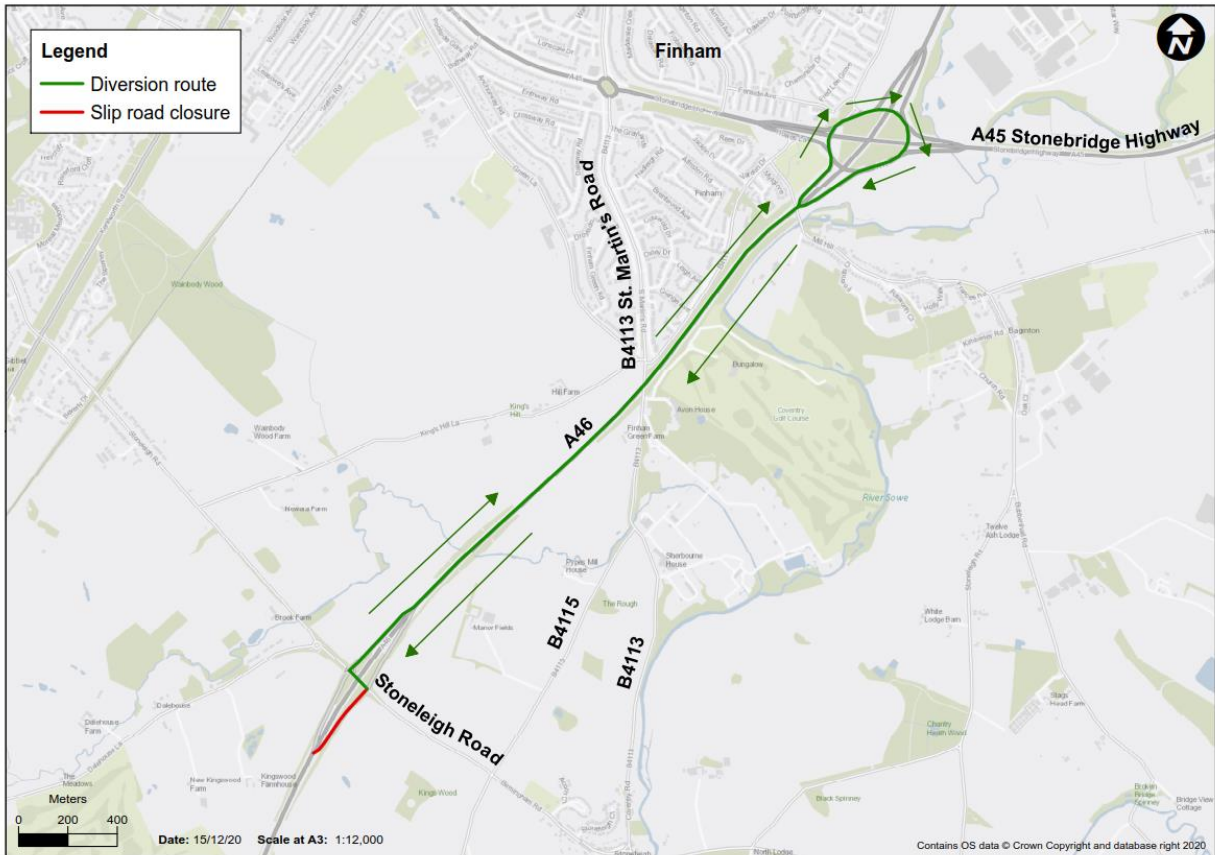
What we will do
