High Speed Two (HS2) is the new high speed railway for Britain. We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current COVID-19 strategy makes clear that construction activity can continue as long as it complies with this guidance. The health and safety of our workforce and the communities we affect is our key priority. Please be assured that those sites that are currently still working are doing so because they can operate within PHE and construction industry guidelines.

Cadent will be moving underground gas pipelines in the Coleshill area until late 2020, to allow for the construction of the new railway. We'll make sure people are aware as the work progresses.

What are we doing?

Cadent needs to carry out some work out at our permanent gas installation off Gorsey Lane. This is near the junction with A446 (Lichfield Road).

This work will only take one day. There will be some noise, but this will be occasional, and we expect it to be low-level.

We'll continue using our existing compound off Watton Lane as our main site for the work we're carrying out in the area.

How will this affect you?

Work will take place within standard working hours. While there may be some noise, this will be occasional and low-level.

There will not be any disruption to your utilities during our works.
