Notice of utility works off Gorsey Lane, near Chattle Hill

High Speed Two (HS2) is the new high speed railway for Britain. We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current COVID-19 strategy makes clear that construction activity can continue as long as it complies with this guidance. The health and safety of our workforce and the communities we affect is our key priority. Please be assured that those sites that are currently still working are doing so because they can operate within PHE and construction industry guidelines.

To continue to ensure a safe and reliable gas supply and to allow for the construction of the new railway, Cadent will be moving underground gas pipelines in the Coleshill area until late 2020.

What are we doing?

So that we can carry out the work safely, we need to make operational changes to the pipelines. We will need to do this at our existing permanent gas installation off Gorsey Lane near the junction with the A446 (Lichfield Road). We will need to carry out the work at various points throughout July.

The work is scheduled to be carried out on:

- 6 July 2020, for around three days
- 27 July 2020 for around three days

There will be some noise while we carry out the work, but this will only be at occasional points between 8:00am and 8:00pm during the dates above. There will not be any disruption to your utility supplies.

We may need to repeat the work on further occasions. We will let people know about this in advance.

How will this affect you?

We apologise in advance for any inconvenience this causes.

All activity will take place between the hours of 8:00am and 8:00pm and while there will be some noise, this will be occasional. There will be some increased vehicle movements, though we will look to keep this to a minimum and outside of peak traffic times.
