Notice of upcoming footpath closure near Middleton

High Speed Two (HS2) is the new high speed railway for Britain. Cadent is currently moving an existing gas pipeline near Church Lane, north east of Middleton, to facilitate HS2's construction and to continue to ensure a safe and reliable gas supply.

What are we doing?

Since May 2019, we've been working to move an existing pipeline in land north east of Middleton.

We will now be carrying out routine testing on the relocated pipeline. To be able to do this safely, we need to close the footpath that crosses our site for a period of up to four days. This has been discussed and agreed with both Warwickshire and Staffordshire County Councils.

From 29 November 2019, the footpath that runs between Middleton and Portleys Lane, south of Drayton Bassett, will be closed.

The footpath will remain closed at all times until 02 December 2019, when our testing is complete.

In advance of the closure, we will put signs in place to make sure everyone is aware.

All our activities will take place within the existing site and we'll continue to access our site from the A4091.

How will this affect you?

The footpath closure needs to remain in place outside of usual working hours, so we can carry out the test safely. No construction activity will take place out of hours, but a small number of workers will be on-site to monitor the test.

We apologise for any inconvenience caused by the footpath closure.

Duration of closure

- From 29 November 2019 until 02 December 2019
- The footpath will be closed for the entirety of this time
- Our core working hours will be 8.00am to 6.00pm (Mon-Fri) and 8.00am to 1.00pm (Sat)
- We will be on-site one hour either side of these times for set-up and close-down

What to expect

- Access off the A4091, so construction traffic will not travel along Church Lane or through Middleton
- We will be using standard construction equipment and vehicles. This will be during normal HS2 working hours.
- 24-hour security on site
- Utility supplies in the area will not be affected by these works

What we will do

- Inform you as our work progresses
- Make sure there is minimal disruption to local people
- Maintain a safe working environment
