High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI is working in partnership with HS2 Ltd to build the new high speed railway in your area.

The work we will be doing

We will be carrying out trial trenching, along a section of verge on the Kingsbury Road, which will involve digging into the ground to establish what is underneath the surface. This will provide us with information on the location of underground utilities.

For the work to be completed in a safe environment, we will be installing temporary traffic lights on Kingsbury Road.

When these works will take place

These works will take place on Monday 14 December 2020.

HS2 and the COVID-19 outbreak

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current COVID-19 strategy makes clear that construction activity can continue as long as it complies with this guidance.

Our working hours will be 8.00am to 5.00pm.

Our workforce will be on site 1 hour before and after to set up and take down our work equipment.

Some low level noise will be generated from the work we are completing.

Inform you in advance of any changes to the date shown.

Keep all sites safe and secure.


