Temporary road closure – Long Itchington Road East

High Speed Two (HS2) is the new high speed railway for Britain. Early works for HS2 are now underway in your area, carried out by LM – a joint venture between Laing O'Rourke and J. Murphy & Sons.

Temporary road closure on Long Itchington Road East

A section of Long Itchington Road East (National Cycle Rte. 41) will be required to close from the 8 March until 11 April 2021. The closure is required to build a new access point, utilities works and construct new road crossings. Access will still be maintained for pedestrians, cyclists, households and businesses along the route and a clearly signposted diversion will be in place (see map).

Access to properties

If your property frontage is within the closure points, we will work with you to manage access into and out of your property. You may sometimes experience a short delay whilst we move machinery or create a safe path within the closed area during our working hours.

HS2 during COVID-19

We are continually reviewing work on our sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current COVID-19 strategy makes clear that construction activity can continue as long as it complies with this guidance. The health and safety of our workforce and the communities we affect is our key priority. Sites that are working are operating within PHE and construction industry guidelines.

Monday – Friday between 8:00am and 5.00pm. We might be on site for up to one hour before or after these times, to set up or pack up.

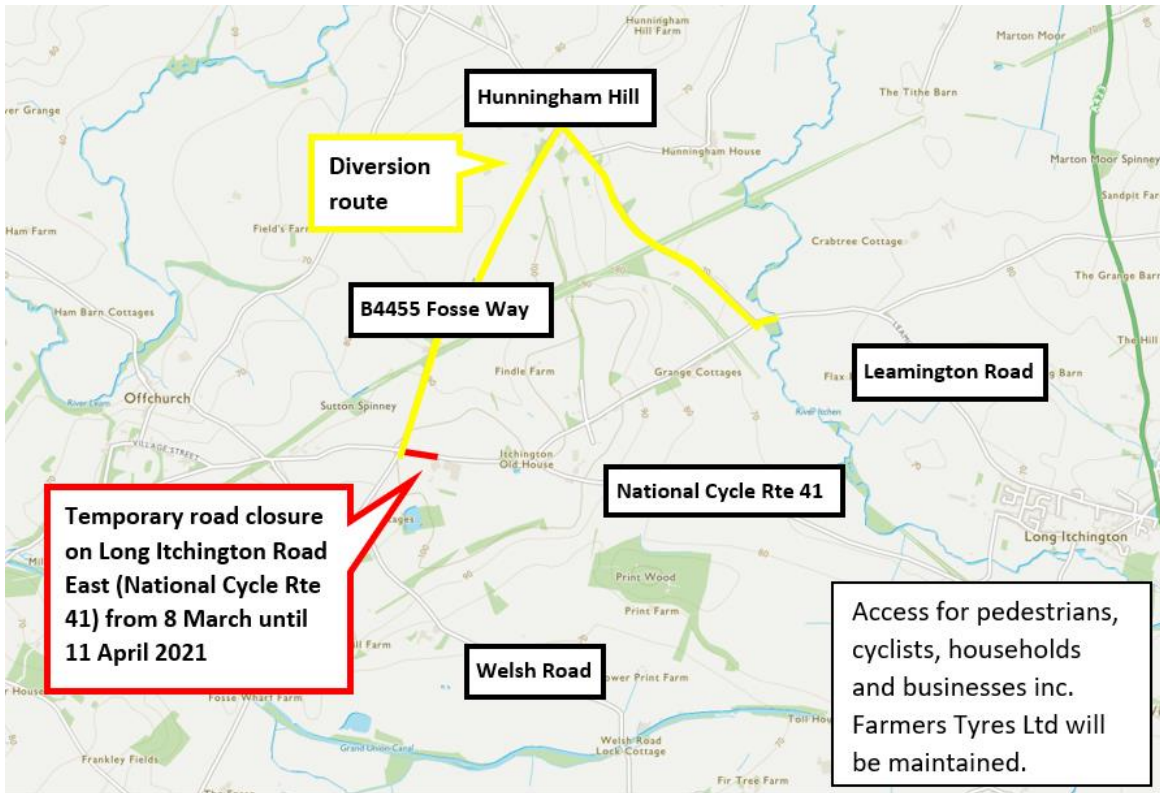
