



Notice of Balfour Beatty VINCI works on Network Rail asset

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working on behalf of HS2 Ltd to build the new high speed railway in your area.

Network Rail works

Balfour Beatty VINCI and our subcontractor will be working on the Network Rail train line to install lineside protection, which will enable us to create a safe environment for our construction workers and users of the existing rail network, while we construct HS2. We will access the working area through the existing Network Rail access point close to Lea Martson.

What work will be taking place

We will access onto the Network Rail train line and complete the installation of lineside protection within land towards Faraday Avenue. These works will take place approximately 1 mile away from Lea Martson, but our access point is closer.

Working hours

In order to reduce the effects we have on normal rail operations, lineside working will take place outside of normal working hours overnight and throughout the day on weekends. In January our working hours will be 20:00 – 08:00 and in February our working hours will be 08:00 – 20:00.

- January 2021 to March 2021

What to expect

- Use of existing Network Rail access point, near Lea Martson
- Small increase of vehicles in the local area
- Works will include BBV constructing lineside protection on Network Rail asset
- There may be occasional deliveries mid-week
- Working hours 20:00 – 08:00 Saturday and Sunday in January
- Working hours 08:00-20:00 Saturday and Sunday in February

- Keep all sites safe and secure.

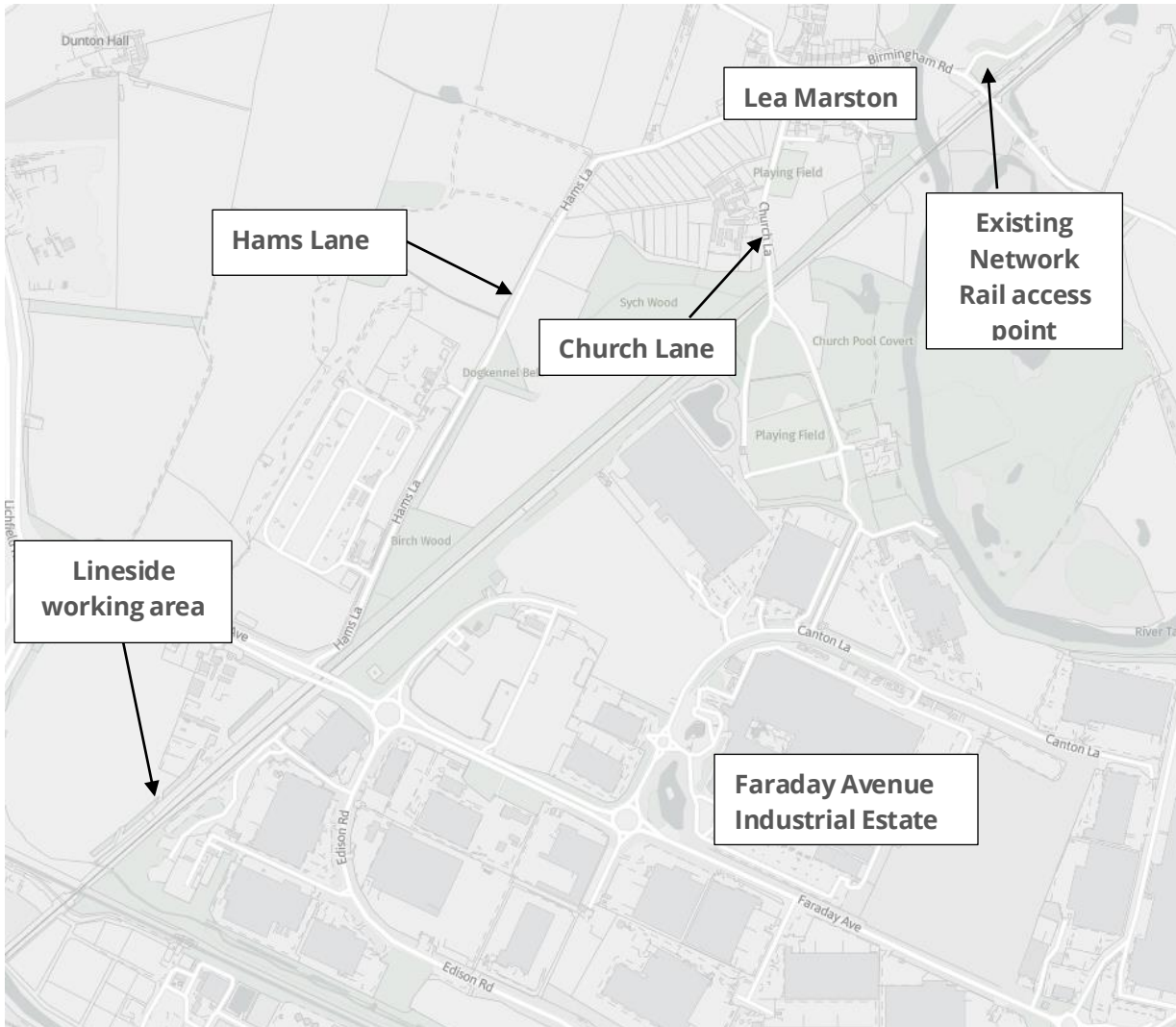
