Temporary traffic lights on Ashow Road

High Speed Two (HS2) is the new high speed railway for Britain. Early works for HS2 are carried out by LM – a joint venture between Laing O'Rourke and J. Murphy & Sons.

LM will be using two-way traffic lights on Ashow Road, in the Ashow and Kenilworth area, to create a safe zone for accessing an HS2 worksite between the B4115 and the A46.

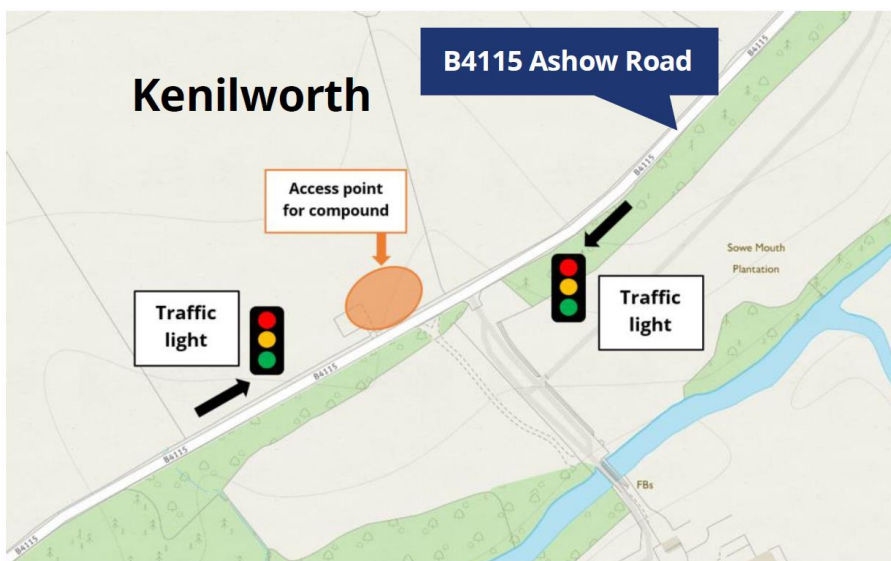
The traffic lights will be in place in this area from **Monday 3 February , 8am-5pm** for up to **two weeks** (subject to site and weather conditions), until a new access point is formed by LM.

Ashow Road will remain open

Ashow Road will remain open – with traffic signals guiding cars and lorries through this section of the road. The lights will be in operation during our working hours and will be lifted from the road when we're not at work.

Lights and signs in this area will help us enter and exit the access point (coloured orange on the map), enabling construction of a temporary compound for HS2. The compound will support the safe delivery of early and main works for the railway.

Duration of works

We're due to start work on **Monday 3 February**. We expect to complete the work in **2 weeks**, subject to site and weather conditions

Temporary traffic lights will be in place from **8am-5pm, Monday-Friday**. We may be on site up to an hour before and an hour after those times to set up or pack up.

Potential delays on the road during peak traffic.
