Notice of weekend traffic management on A425 Leamington Road

High Speed Two (HS2) is the new high speed railway for Britain. Early works for HS2 are carried out by LM – a joint venture between Laing O'Rourke and J. Murphy & Sons.

Works planned north of Southam

We are working in this area to prepare the route of the new railway. This work includes hedgerow and vegetation removal and installing fencing ahead of constructing the Long Itchington Wood tunnel.

There will be temporary weekend traffic management

To ensure a safe working area we will be operating temporary traffic lights along the A425 Leamington Road, near Dallas Burston Polo Club. These signals will be operational on **Saturday 11th April** between **8:00am and 1:00pm**. Our teams will be on site one hour before and one hour after the works to set up and secure the site at the end of each day.

Access to properties will be maintained throughout the works. If required marshalls will escort pedestrians safely through the work area.
