High Speed Two (HS2) is the new high speed railway for Britain. Early works for HS2 are carried out by LM – a joint venture between Laing O'Rourke and J. Murphy & Sons.

We are working near Offchurch

We will be working near Offchurch and Hunningham Road to prepare the route of the new railway ahead of future main construction work. This includes constructing an ecological mitigation site, and some vegetation and tree removal.

We need to work at the weekend

In order to complete this work in good time and maintain progress on the delivery of HS2, we will be continuing our work on weekends in June. This includes Saturday 27 June and Sunday 28 June. We may also need to work on weekends in July.

Our working hours are between 8:00am and 5:00pm, with an hour before and after these times to set up or secure the site.

HS2 and the COVID-19 outbreak

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current COVID-19 strategy makes clear that construction activity can continue as long as it complies with this guidance.
