Notice of Esso Oil Pipeline Diversion

High Speed Two (HS2) is the new high speed railway for Britain. Esso is working on behalf of HS2 Ltd in your area.

Esso will be working on a diversion, which will consist of building a new section of pipeline, then connecting it to the existing line and removing the old pipe. The works will be split into two stages:

- Enabling works vegetation clearance, motorway fencing erection and the provision of a safe access and egress from Water Orton Road into the works compound.
- 2. Main pipeline works preparing land, setting up compound, welding of new pipeline, excavating and laying pipeline, testing and commissioning.

What enabling works are we doing

Our initial enabling works will start on Tuesday 19 November. We will be working in a field and in Water Orton Road for two weeks. From 9 December we will need to use temporary traffic lights on the Water Orton Road so that we can construct the site entrance safely. We will remove the lights when the construction of the entrance is complete.

Preparations for the main diversion works will start in January

The main works will start on Monday 6 January 2020 with the construction of our compound. The pipeline diversion will be away from the Water Orton Road so there should be minimal disruptions.

We will send a notice out nearer to the start of the works with more details.

Duration of works

The enabling works will start on 19 November and take 2 weeks.

The main diversion will start in January 2020.

The works will be complete in May 2020.

Temporary traffic lights on the Water Orton Road from 9 December.

Keep all sites safe and secure, while keeping disruption to a minimum.
