## **Notice of road closure -**Gilson Road, Gilson

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty Vinci is working on behalf of HS2 Ltd to build the new high speed railway in your area.

### What work will we be doing?

We are currently completing Ground Penetrating Radar surveys on Gilson Road today and tomorrow – 4<sup>th</sup> & 5<sup>th</sup> May.

Over the coming weeks we will return to Gilson Road to carry out further work under a week-long temporary road closure. The provisional date for the road closure is 18<sup>th</sup> May, however this is still to be confirmed - once we are clear on this date, we will let you know.

The road closure will enable our contractors to remove vegetation and create an access point for our test piling compound.

Once this initial work is complete, we will set up a satellite compound and a temporary piling platform, which will enable the test piling to take place. We expect to be in this area for a further 6 months.

Throughout the 6-month period, there will be occasions where Traffic Management will have to be put in place to complete our works. We will keep you updated through www.hs2inwarwicks.commonplace.is.

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current COVID-19 strategy makes clear that construction activity can continue as long as it complies with this guidance.

- 5-day road closure
- Road closure is planned from 18<sup>th</sup> May – date is subject to change.

- Road closure on the North section of Gilson Road
- Road closure in place from 9:30am – 3:30pm
- Increased levels of noise from our machinery.
- Slight increase to traffic
- Our workforce to be on site 1 hour before and 1 hour after, to set up and take down equipment.

- Keep all sites safe and secure.


