



## Notice of road closure – A45 service road and East Way

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working on behalf of HS2 Ltd to build the new high speed railway in your area.

### Utility surveys

In July, we sent out a notification to outline the start Balfour Beatty VINCI work within the Interchange station area. Continuing with these works, we will be completing ground investigation surveys within side verges of the A45 service road and East Way. These surveys help us identify what utilities are within the area.

### When will the work take place

The surveys are due to take place over 8 nights starting from **Monday 2nd November until Wednesday 11<sup>th</sup> November 2020**.

To complete our works in a safe environment, we will be implementing temporary night time road closures to the A45 service road and East Way. The temporary closures will be in place from 9:00pm – 5:00am. If works are completed early we will not require all of the closures.

Road signage will be in place to highlight the diversion routes.

### HS2 during the COVID-19 pandemic

We are continually reviewing the works on our construction sites in line with the Government and Public Health England (PHE) advice on dealing with coronavirus. The Government's current coronavirus strategy makes clear that construction activity can continue as long as it complies with this guidance. The health and safety of our workforce and the communities we affect is our key priority. Please be assured that those sites that are currently still working are doing so because they can operate within PHE and construction industry guidelines.

- Temporary overnight road closures on A45 service road and East Way,
- Monday 2nd November until Wednesday 11<sup>th</sup> November 2020.
- Temporary overnight road closure from 9:00pm – 5:00am

### What to expect

- Road signage in place to highlight the diversion route.
- Low levels of noise from our machinery
- Our workforce to be on site 1 hour before and 1 hour after, to set up and take down equipment.

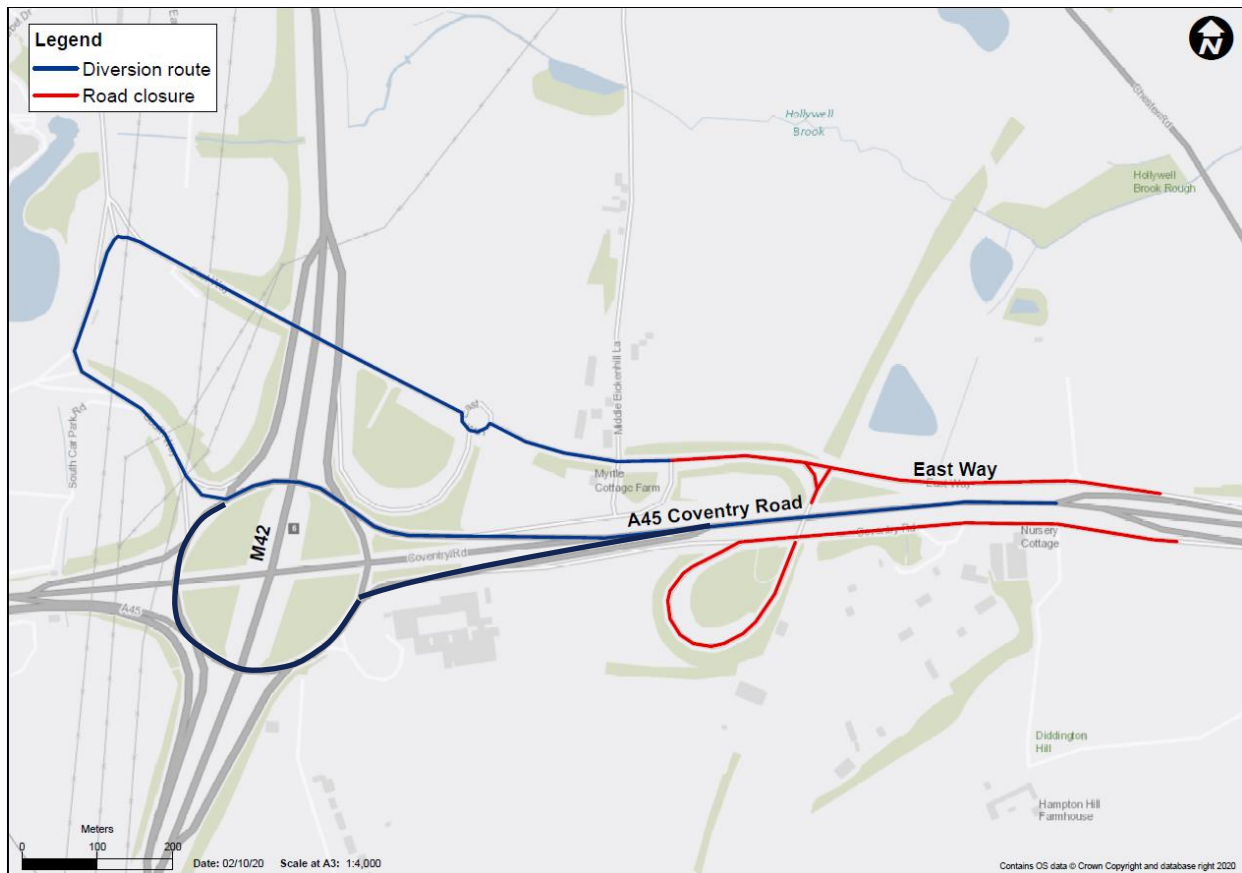
