
Notice of Traffic Management and Ground Investigation Surveys: B4115



Information about HS2 construction works during the coronavirus (COVID-19) pandemic


We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current COVID-19 strategy makes clear that construction activity can continue as long as it complies with this guidance. The health and safety of our workforce and the communities we affect is our key priority. Please be assured that those sites that are currently still working are doing so because they can operate within PHE and construction industry guidelines.

What work will we be doing?

We will be undertaking ground investigation surveys, which will help us to finalise the detail design for the route to be constructed. The ground investigation surveys will be carried out on a track located in Stoneleigh Park near to the entrance to the A46 compound.

Where will the surveys be taking place?

The surveys will be taking place in the area outlined below





Duration of works

- Two-way traffic management will be in place on 27th May between 8.00pm and 6.00am.
- Our workforce will be on site 1 hour before and after to set up and take down our work equipment.

What to expect

- Installation of signage on the roadside.
- A potential increase in noise from the work we are completing.
