
# **Notice of Swept Path Analysis**

High Speed Two (HS2) is the new high speed railway for Britain. As we prepare for construction, we will be carrying out a Swept Path Analysis in your area. The purpose of this survey is to identify route and pinch points to the transportation of the Tunnel Boring Machine to the Long Itchington Wood Tunnel Main Compound.

## Where is the work being carried out?

The survey will commence from the Dallas Burston Polo Club on the A425 and finish at Ridgeway Lane Ufton.



## When will these works take place?

Our contractor will carry out a Swept Path Analysis and topographic survey in the week beginning 16 March 2020.

#### What should I expect?

The swept path analysis survey will involve a drive through with specialised survey equipment to record the appropriate readings and will not require any special traffic management measurements to be put into place. The topographic survey will involve Collect and Sons stopping at various points to measure the shape of the land along the planned route.
