
High Speed Two (HS2) is the new high speed railway for Britain. Initial works have now started and are carried out by LM - a joint venture between Laing O'Rourke and J. Murphy & Sons.

We will be continuing our works to install utilities to the tunnel compound from Harbury substation, pulling cables through which means that we will need to excavate pits within the carriageway to join the cables.

Phase 1 will complete on the 9th March. Phase 2 will complete on 14th April leading to **Phase 3** requiring the **B4552 to be closed from the 10th March until 10th May between the A425 junction to Deppers Bridge.** (please see map below). All dates are subject to change.

Please note: Bascote Heath Road and B4552 will both be closed between 10th March to 14th April due to an overlap where cables need to be installed. **However, access will still be maintained for households and businesses along both routes and a clearly signposted diversion will be in place.**

Duration of works

Phase 2 17 February to 14 April

Phase 3 – 10 March to 14 April & from 14 April to 10 May.

Full road closure 24/7, seven days a week with working hours 8.00am to 6.00pm, subject to site and weather conditions.

Our contractors may also be on site for up to one hour beforehand and after to set up and pack up.

Some noise from on-site machinery during working hours.

Maintained access for emergency services and to properties and businesses along the route.
