High Speed Two (HS2) is the new high speed railway for Britain. Early works for HS2 are carried out by LM – a joint venture between Laing O'Rourke and J. Murphy & Sons.


There will be temporary traffic management

To enable Western Power Distribution to remove trees underneath local power lines, we will be operating temporary traffic lights along Cromwell Lane. These signals will be operational for three weeks from the week commencing **20 July** between **9:30am and 3:30pm**. Our teams will be on site one hour before and one hour after the works to set up and secure the site at the end of each day. Marshalls will escort pedestrians safely through the works as required.

HS2 and the COVID-19 outbreak

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current COVID-19 strategy makes clear that construction activity can continue as long as it complies with this guidance.

The health and safety of our workforce and the communities we affect is our key priority. Please be assured that those sites that are currently still working are doing so because they can operate within PHE and construction industry guidelines.

For three weeks from the week of 20 July between 9:30am and 3:30pm. These times and dates are subject to change.

Our teams will be on site one hour before and one hour after the works to set up and secure the site at the end of each day.

Keep all sites safe while keeping disruption to a minimum.

Ensure all traffic management is clearly signed.
