

Emergency temporary traffic lights – Burton Green

High Speed Two (HS2) is the new high speed railway for Britain. Early works for HS2 are now underway in your area, carried out by LM – a joint venture between Laing O'Rourke and J. Murphy & Sons.

LM needs to carry out essential repairs to a damaged chamber on Hob Lane in Burton Green. To save further traffic management a later date we will also complete trimming of the vegetation for the pedestrian crossing visibility splays. These works will require three-way temporary traffic lights with a lane closure to be installed on Hob Lane between 9:30am and 2:30pm. Works are planned to take place during week commencing 25 January for three days (please see map below).

Due to width restrictions on Hob Lane, there may be occasions where traffic is required to be halted in all directions for up-to 15 minutes to allow HS2 construction vehicles to access the worksite safely. Current traffic management on Red Lane will be lifted during these works and reinstated when works are complete. All works are subject to consent, site and weather conditions. Dates are also subject to change.
