Notice of traffic management on A425 Leamington Road

High Speed Two (HS2) is the new high speed railway for Britain. Early works for HS2 are carried out by LM – a joint venture between Laing O'Rourke and J. Murphy & Sons.

Works planned near Southam

Over the coming weeks we'll be working near Southam to prepare the route of the new railway ahead of main works construction. This work includes hedgerow and vegetation clearance as well as installing fencing.

There will be temporary traffic management

To ensure a safe access to our work site we will be operating temporary traffic lights along the A425 Leamington Road, near Dallas Burston Polo Club. These signals will be in operation between **9:30am and 3:30pm** during the week commencing **3rd February**. Our teams will be on site one hour before and one hour after the works to set up and secure the site at the end of each day.

Access to properties will be maintained throughout the works.

Marshalls will escort pedestrians safely through the works as required.

Why we're doing this work

We need to prepare as much of the route as possible over the coming months. This will ensure that our main construction work can commence on time.

Temporary traffic lights along the A425 Leamington Road.

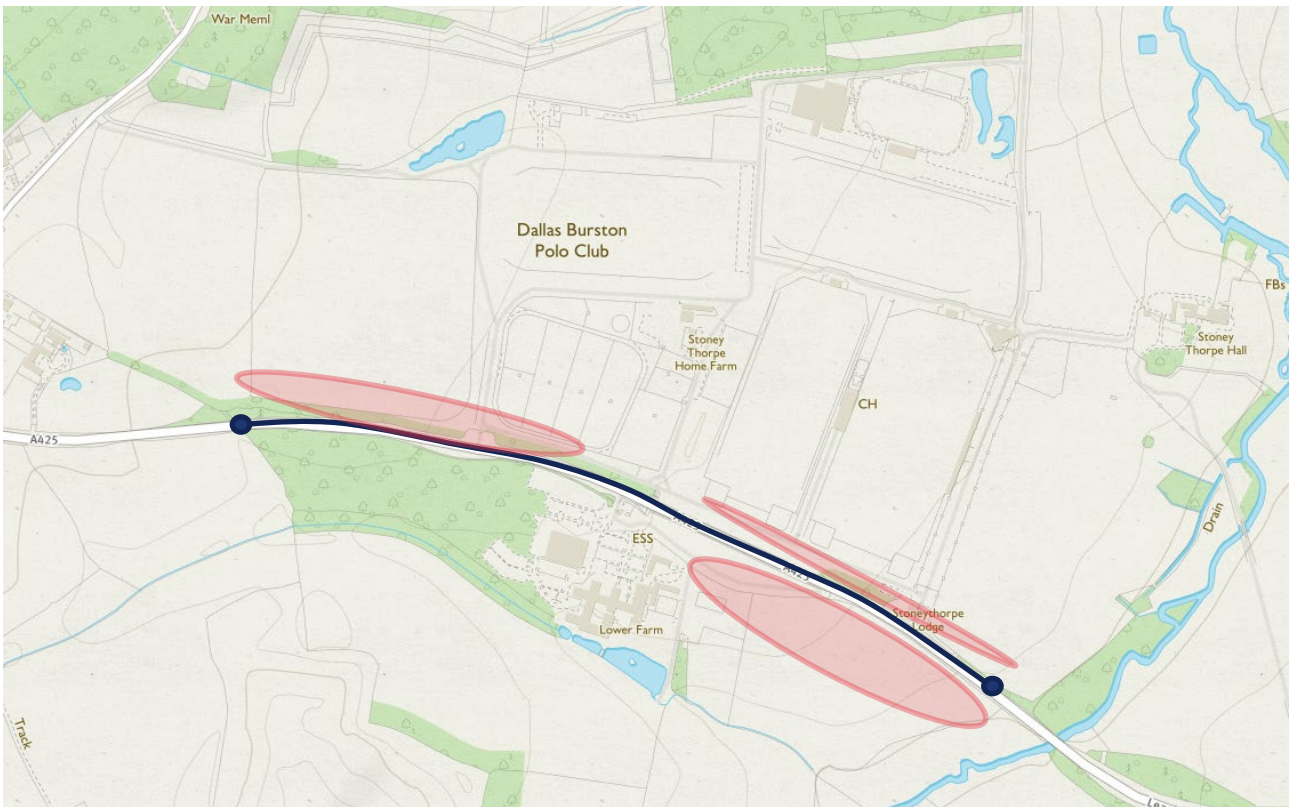
You will see us working on site during the day.

About our Community and Business Funds

The CEF is designed to give communities the opportunity to share in the benefits of HS2. It is an allocated fund that communities are able to apply for, to help to support local projects that aim to improve their local area.

The BLEF is designed to support local economies that may be disrupted by the construction of HS2. BLEF grants are for local business support organisations and local authorities to help maintain business activity in local communities.
