

# Notice of traffic management on Birmingham Road

High Speed Two (HS2) is the new high speed railway for Britain. Early works for HS2 are carried out by LM – a joint venture between Laing O'Rourke and J. Murphy & Sons.

# We have work planned near Coleshill

Over the coming weeks we'll be working near Coleshill to prepare the route of the new railway ahead of main works construction. This work includes vegetation and hedgerow clearance alongside constructing fencing.

#### There will be temporary traffic management

To ensure a safe access to our clearance sites alongside Birmingham Road, near M6 Toll, we will be operating temporary traffic lights. These signals will be in operation between **9:30am and 3:30pm** from the week commencing **27<sup>th</sup> January** for two weeks, subject to site and weather conditions. Our teams will be on site one hour before and one hour after the works to set up and secure the site at the end of each day.

Access to properties and businesses will be maintained throughout the works.

#### Why we're doing this work

We need to prepare as much of the route as possible over the coming months. This will ensure that our main construction work can commence on time. It is also important to complete this work during this time of year as it is outside of key periods in the ecological calendar and helps to minimises our impact on local wildlife.

#### What we will do

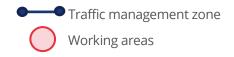
Keep all sites safe and secure, while keeping disruption to a minimum.

Temporary traffic lights with a single lane closure will be in operation between 9:30am and 3:30pm from the week commencing 27<sup>th</sup> January for two weeks, subject to consent. Traffic lights will be mobile, with locations within the traffic management area changing as required.

Our teams will be on site one hour before and one hour after the works to set up and secure the site at the end of each day.

Access to properties and businesses will be maintained during works.
