

Notice of temporary hard shoulder closure on M6 near Water Orton

High Speed Two (HS2) is the new high speed railway for Britain. Early works for HS2 are carried out by LM – a joint venture between Laing O'Rourke and J. Murphy & Sons.

Works planned near Water Orton Road

Over the coming months, we'll be working near Water Orton Road and the M6 to prepare the route for the new railway. This work includes vegetation clearance and installing some fencing.

Where the hard shoulder will be closed

LM will be temporarily closing a section of the hard shoulder along the M6 southbound after Junction 5 in order to facilitate vegetation clearance alongside the motorway. The closure will be in place on weekdays between **9:30am-3:30pm** during the week of 27th January, subject to consent and weather conditions.

Why we're doing this work

We need to prepare as much of the route as possible over the coming months. This will ensure that our main construction work can commence on time. It is also important to complete this work during this time of year as it is outside of key periods in the ecological calendar and helps to minimises our impact on local wildlife.
