High Speed Two (HS2) is the new high speed railway for Britain. Early works for HS2 are carried out by LM – a joint venture between Laing O'Rourke and J. Murphy & Sons.

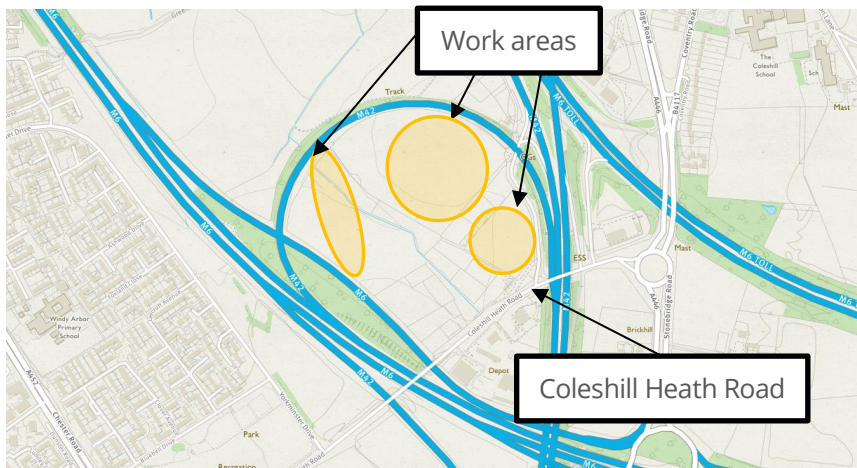
### Works planned near M6 Compound site

Following our prior notification regarding vegetation clearance, we want to inform you that over the coming weeks we will be working north off Coleshill Heath Road to carry out critical work to prepare site of the upcoming M6 Compound. This work includes minor vegetation clearance and fencing construction.

You may see us working on site during the day. Our work hours are between 8:00am and 6:00pm on weekdays and 8:00am-1:00pm on Saturdays. Our teams will be on site one hour before and one hour after any works to set up and secure the site at the end of each day.

### Why we're doing this work

In order to deliver Phase One of HS2, connecting London Euston to the West Midlands, we need to prepare as much of the route as possible between October 2019 and March 2020. This will ensure that our main construction work can commence on time. It is also important to complete this work during this time of year as it is outside of key periods in the ecological calendar and minimises our impact on local wildlife.
