
Updated Notification Emergency Closure – Welsh Road

High Speed Two (HS2) is the new high speed railway for Britain. Initial works have now started and are carried out by LM – a joint venture between Laing O'Rourke and J. Murphy & Sons.

The Welsh Road emergency closure will now be extended for an additional week, between the Fosse Way junction and Bascote Heath Road junction. The road will remain closed for two weeks. The reason for the closure is to undertake emergency repair work to ensure the road is kept safe and secure for all users.
