High Speed Two (HS2) is the new high speed railway for Britain. Early works for HS2 are carried out by LM – a joint venture between Laing O'Rourke and J. Murphy & Sons.

Works planned in Kenilworth

LM will be working near Kenilworth to establish new woodland, wetland and wildlife habitats. We'll be working to the North of Kenilworth planting over 10,000 trees and creating a new pond.

Why we're doing this work

As part of preparing sites for the construction of HS2 we are undertaking a major conservation project to create a 'green corridor' alongside the route of HS2. This will include a network of habitats ranging from woodlands and meadows to wetlands and ponds. They will replace any habitats affected by the construction of HS2, while conserving and enhancing existing sites. We're committed to 'no net loss' in habitats for wildlife over the course of our works.
