# Notice of works on Gilson Road, Gilson

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty Vinci is working on behalf of HS2 Ltd to build the new high-speed railway in your area.

# What work will we be doing?

In February, we notified you of road closures on Gilson Road. Unfortunately, the works were unable to take place in February and have been rearranged for 23<sup>rd</sup> & 24<sup>th</sup> March.

We will be working in 2 locations on Gilson Road, outlined below. During the 23<sup>rd</sup> and 24<sup>th</sup> March, we will have lane closures and road closures in place. Access to frontages along Gilson Road will be maintained. The traffic management will enable our contractors to remove vegetation and create an access points for our test piling compounds.

Once this initial work is complete, we will set up a satellite compound and a temporary piling platform, which will enable the test piling to take place. We expect to be in this area for a further 6 months.

Throughout the 6-month period, there will be occasions where Traffic Management will have to be put in place to complete our works. We will keep you updated through www.hs2inwarwicks.commonplace.is.

## What is Test Piling?

Test Piles are constructed by drilling into the ground to a required depth. As the machine drills into the ground the spoil travels up to ground level, where the machine is then cleaned. Once the piling machine reaches the required depth, concrete is then pumped in to the bottom of the pile. The machine is then withdrawn in a controlled manner until the concrete is to ground level. A steel reinforcement cage is then placed into the fluid concrete.

All planned traffic routes have been approved by the local highways team and will always be adhered to.

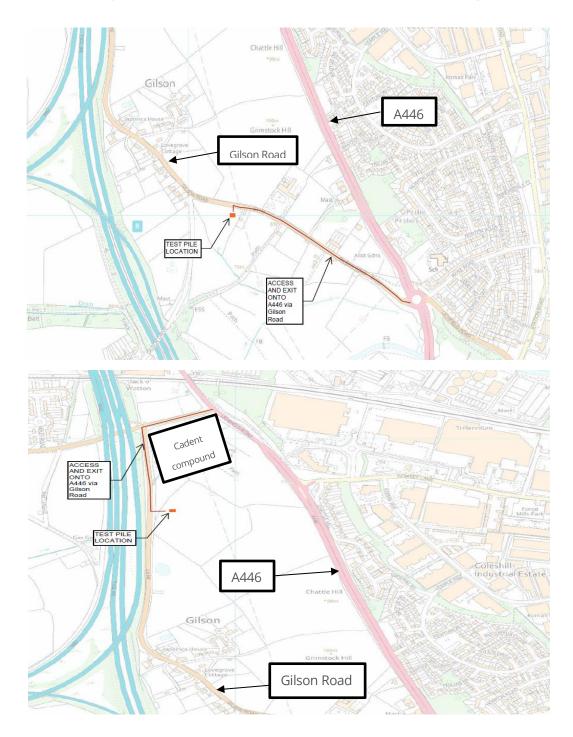
