Notice of pipeline diversion works south of Water Orton

High Speed Two (HS2) is the new high speed railway for Britain. Cadent is moving underground gas pipelines in the Coleshill area, to allow for the construction of the new railway and to continue to ensure a safe and reliable gas supply. We expect all our work in the Coleshill area to be completed by October 2020.

We started work to move one of the pipelines in November 2019 by constructing a tunnel near our main works compound off Watton Lane. We will now be starting main work to move the pipeline on land south of Water Orton, in March 2020.

What are we doing?

To avoid traffic going through Water Orton, we'll mainly be accessing our working area and temporary works compound via Gypsy Lane (which will remain closed).

We will continue to access the diversion working area east of the M6 Toll/M42 from Gilson Road. We will also be carrying out some work from our existing gas installation off Attleboro Lane.

The work will include:

- Digging trenches for the new pipeline route in land south of Water Orton
- Welding the pipe together then installing it in the trench
- Connecting and testing the new pipe

There will be 24-hour security on site so we can maintain a safe working environment. Please note, there will be no on-site lodging.

How will this affect you?

Construction vehicles will not travel through Water Orton and will only occasionally use the southern end of Attleboro Lane to access the site.

Work will take place inside usual working hours. There will not be any disruption to your utilities during our works.

- March 2020 to October 2020
- Our core working hours will be 8.00am to 6.00pm (Mon-Fri) and 8.00am to 1.00pm (Sat)
- We will be on-site one hour either side of these times for set-up and closedown

- Vehicles will access the works site via Gypsy Lane, and we will keep all use of the southern end of Attleboro Lane to a minimum
- 24-hour security on site

- Make sure there is minimal disruption to local people
- Maintain a safe working environment
