Notice of foot and cycle path closure in Chattlehill

High Speed Two (HS2) is the new high speed railway for Britain. Cadent will be moving underground gas pipelines in the Coleshill area, to allow for the construction of the new railway and to continue to ensure a safe and reliable gas supply.

We will be starting main work to move one of the pipelines east of the A446 in March 2020. We expect all our work in the Coleshill area to be completed by October 2020.

What are we doing?

Ahead of our main works starting, we need to temporarily close the foot and cycle path that runs from the A446 Lichfield Road between Bromwich Court and Auria Solutions. This is so we can carry out some site clearance activities.

The footpath will initially be closed from **17 February** for approximately five days. A foot and cycle path diversion will be in place via the Lichfield Road footpath and Gorsey Lane.

We'll be putting up signs in the local area to let pedestrians and cyclists know about the closure.

How will this affect you?

We will occasionally need to temporarily close the foot and cycle path as our works progress, but we will look to open this whenever possible to minimise disruption.

We apologise for any inconvenience caused. We will update people with the next steps involved as our work progresses
