Healthy Route - Public Realm Works

Loughborough Road/Fiveways Junction/Near Minet Road and Near Barrington Road

Dear Resident/To Whom It May Concern

Lambeth Council via our framework contractor Ringway, will be undertaking public realm improvements to deliver a flagship Healthy Route along:

Loughborough Road, between Ridgway Road and Fiveways junction inclusive (junction of Loughborough Road, Fiveways Road, Lilford Road and Akerman Road). The scheme aims to provide a safe, accessible and pleasant route for people walking, cycling, wheeling and using the bus. Details of the works

Proposed improvements include:

- New and upgraded raised pedestrian and cycle parallel zebra crossings to enhance and improve pedestrian and cycling safety.
- A continuous cycle track on each side of Loughborough Road (between Fiveways Junction and Ridgway Road),
- protected using traffic wands to provide light segregation.
- Buildouts widened footways and continuous level footways to create more pedestrian space and prioritise pedestrians crossing the road.
- Bus stop bypasses and shared use bus stop boarders (SUBBs) to ensure that cycles and buses do not interact at bus stops and bus times are unaffected.
- Additional pedestrian and cycle safety features at Fiveways junction, including cycle gates with low level advanced release signals, "two stage right-turns" to enable cycles to cross in two stages, a banned turn to reduce vehicle turning movements.
- Approximately 8,000m2 of carriageway resurfacing.

Phasing and timings of the works

Works will be carried out in phases over approximately 24 weeks from 12th June 2023 to 30th November 2023, including carriageway resurfacing. Due to the nature of the works, the dates for the various phases of work are subject to change.

This letter concerns the Civils Works which is to be carried out from 12th June to 30th November 2023, following which carriageway resurfacing works will take place, a further follow up letter in relation to those dates will be sent nearer the time.

- The programme of the civils works is shown below in Table 1.
- From 08:00 to 18:00hrs Monday to Friday
- From 08:00 to 14:00hrs on Saturdays

An updated letter for the carriageway resurfacing works and associated traffic management plans will follow in due course.



The 9 Work Phases are tabulated below, working Areas per phase are shown in Appendix A.

This will require no vehicles to be parked in the road within the working and safety zones, as indicated by cones and suspension signs. **Any obstructing vehicles will be relocated to nearby spaces/roads.**





Phase 1&2 - Civils - Area of Works






Phase 3&4 - Civils - Area of Works
