The right to manage is a way in which leaseholders can gain control over the management of their buildings. The right to manage consultation paper sets out provisional proposals to make the procedure simpler, quicker and more flexible.

Commonhold is an alternative to leasehold ownership, enabling ownership of flats on an outright, freehold basis. Freehold is ownership which lasts forever, whereas leasehold provides time-limited ownership (for example 99-years). The commonhold consultation paper sets out provisional proposals to reform the law of commonhold to make it a workable alternative to leasehold.
