

LOCAL GOVERNMENT AND PUBLIC INVOLVEMENT IN HEALTH ACT 2007

The East Cambridgeshire District Council (Reorganisation of Community Governance) Order 2018

Made on 13 July 2018

Coming into force in accordance with Article 1 of this Order

East Cambridgeshire District Council (“the Council”), in accordance with section 83 of the Local Government and Public Involvement in Health Act 2007 (“the 2007 Act”), has undertaken a community governance review and made recommendations dated 12 July 2018.

The Council has decided to give effect to those recommendations and, in accordance with section 93 of the 2007 Act, has consulted with the local government electors and other interested persons and has had regard to the need to secure that community governance reflects the identities and interests of the community and is effective and convenient.

The Council, in accordance with section 100 of the 2007 Act, has had regard to guidance issued under that section.

The Council makes the following Order in exercise of the powers conferred by section 86, 98(3) & 240(10) of the 2007 Act.

Citation and commencement

1.

- (1) This Order may be cited as the East Cambridgeshire District Council (Reorganisation of Community Governance) Order 2018.
- (2) Subject to paragraphs (3) and (4) below, this Order comes into force on the day after that which it is made.
- (3) Article 20 of this Order shall come into force on the ordinary day of election of councillors in May 2019.
- (4) For the purposes of:
 - (a) this article, and
 - (b) proceedings preliminary or relating to the election of parish councillors for the parish area of Bottisham, to be held on the ordinary day of election of councillors in May 2019, This Order shall come into force on 15 October 2018.

Interpretation

2. In this Order-

“district”	means the district of East Cambridgeshire;
“maps”	means the maps marked “Maps referred to in the East Cambridgeshire District Council (Reorganisation of Community Governance) Order 2018” and deposited in accordance with section 96(4) of the 2007 Act and any reference to a numbered sheet is a reference to the sheet of the map which bears that number;
“ordinary day of election of councillors”	has the meaning given by section 37 of the Representation of the People Act 1983; and
“Registration Officer”	means an officer appointed for the purpose of, and in accordance with, section 8 of the Representation of the People Act 1983.

3. Effect of Order

This Order has effect subject to any agreement under section 99 (agreements about incidental matters) of the Local Government and public Involvement in Health Act 2007 relevant to any provision of this Order.

4. Alteration of Ely East and Ely North parish areas.

The area shaded in lilac on the attached map (Map 1) and specified in column 3 of Schedule [1] shall cease to be part of the parish of Ely East and shall become part of the parish of Ely North.

5. Alteration of Ely West and Witchford parish areas.

The area shaded in lilac on the attached map (Map 2, Area 1) and specified in column 3 of Schedule [1] shall cease to be part of the parish of Ely West and shall become part of the parish of Witchford.

6. Alteration of Ely West and Witchford parish areas.

The area shaded in lilac on the attached map (Map 2, Area 8) and specified in column 3 of Schedule [1] shall cease to be part of the parish of Ely West and shall become part of the parish of Witchford.

7. Alteration of Ely West and Witchford parish areas.

The area shaded in lilac on the attached map (Map 2, Area 9) and specified in column 3 of Schedule [1] shall cease to be part of the parish of Ely West and shall become part of the parish of Witchford.

8. Alteration of Wentworth and Witchford parish areas.

The area shaded in lilac on the attached map (Map 2, Area 6) and specified in column 2 of Schedule [1] shall cease to be part of the parish of Wentworth and shall become part of the parish of Witchford.

9. Alteration of Wentworth and Witchford parish areas.

The area shaded in lilac on the attached map (Map 2, Area 7) and specified in column 2 of Schedule [1] shall cease to be part of the parish of Wentworth and shall become part of the parish of Witchford.

10. Alteration of Wentworth and Witchford parish areas.

The area shaded in lilac on the attached map (Map 2, Area 5) and specified in column 2 of Schedule [1] shall cease to be part of the parish of Wentworth and shall become part of the parish of Witchford.

11. Alteration of Wilburton and Witchford parish areas.

The area shaded lilac on the attached map (Map 2, Area 3) and specified in column 2 of Schedule [1] shall cease to be part of the parish of Wilburton and shall become part of the parish of Witchford.

12. Alteration of Wilburton and Witchford parish areas.

The area shaded lilac on the attached map (Map 2, Area 4) and specified in column 2 of Schedule [1] shall cease to be part of the parish of Wilburton and shall become part of the parish of Witchford.

13. Alteration of Wilburton and Witchford parish areas.

The area shaded lilac on the attached map (Map 2, Area 2) and specified in column 2 of Schedule [1] shall cease to be part of the parish of Wilburton and shall become part of the parish of Witchford.

14. Alteration of Sutton and Mepal parish areas.

The area shaded lilac on the attached map (Map 3, Area 1) and specified in column 2 of Schedule [1] shall cease to be part of the parish of Sutton and shall become part of the parish of Mepal.

15. Alteration of Sutton and Mepal parish areas.

The area shaded lilac on the attached map (Map 3, Area 2) and specified in column 2 of Schedule [1] shall cease to be part of the parish of Sutton and shall become part of the parish of Mepal.

16. Alteration of Sutton and Mepal parish areas.

The area shaded lilac on the attached map (Map 3, Area 3) and specified in column 2 of Schedule [1] shall cease to be part of the parish of Sutton and shall become part of the parish of Mepal.

17. Alteration of Sutton and Haddenham parish areas.

The area shaded lilac on the attached map (Map 4) and specified in column 2 of Schedule [1] shall cease to be part of Sutton and shall become part of the parish of Haddenham.

18. Alteration of Wilburton and Wentworth parish areas.

The area shaded lilac on the attached map (Map 5) and specified in column 2 of Schedule [1] shall cease to be part of Wilburton and shall become part of the parish of Wentworth.

19. Alteration of Little Downham and Witchford and Ely West parish areas.

The area shaded lilac on the attached map (Map 6) and specified in column 2 and column 3 of Schedule [1] shall cease to be part of Little Downham and Witchford parishes and shall become part of the parish of Ely West.

20. Alteration of Witcham and Sutton parish area.

The area shaded lilac on the attached map (Map 7) and specified in column 2 of Schedule [1] shall cease to be part of Witcham and shall become part of the parish of Sutton.

21. Number of parish councillors for the parish of Bottisham

The number of councillors to be elected for the parish of Bottisham shall be increased from 11 to 12 as specified in Schedule [2] (Map 8).

22. Electoral Register

The Registration Officer for the district shall make such rearrangement of, or adaptation of, the register of local government electors as may be necessary for the purpose of, and in consequence of, this Order.

23. Transfer of property, rights and liabilities.

The land, property, rights and liabilities described in Schedules 3, 4, 5 and 6 shall transfer on the date specified in Column (2) of those schedules.

24. Order Date

13 July 2018 is the order date for the purposes of the Local Government (Parishes and Parish Councils) (England) Regulations 2008.

EXPLANATORY NOTE

(This note does not form part of the Order)

This order gives effect to recommendations made by East Cambridgeshire District Council for the alteration of the areas of the parish councils for, Ely East, Ely North, Ely West, Witchford, Wentworth, Wilburton, Haddenham, Witcham, Mepal, Sutton, Little Downham and Bottisham.

The electoral arrangements apply in respect of parish elections to be held on and after the ordinary day of election of councillors on Thursday 2 May 2019.

Articles 4 - 20 provides for alterations to parish areas.

Article 21 provides for an increase in parish councillors to Bottisham parish council

Article 22 Obliges the Electoral Registration Officer to make any necessary amendments to the electoral register to reflect the new electoral arrangements.

Article 23 contains details of land, property, rights and liabilities described in the Schedules that shall transfer between the Council's defined within this order on the date specified in those Schedules.

The maps defined in article 23 and explained in articles 4 -20 shows the alterations to parishes. It is available for inspection during normal working hours at the offices of East Cambridgeshire District Council, The Grange, Nutholt Lane, Ely, Cambridgeshire CB7 4EE.
