Crawley Borough Council's response to the draft recommendations for the electoral review of Crawley was considered by Full Council at its meeting held on 1<sup>st</sup> August.

Full Council unanimously agreed to support the draft recommendations for a mixed pattern of 2 and 3 Councillor wards.

Whilst welcoming the draft recommendations, Full Council noted that the draft recommendations proposed to include the Windmill Court and Longmere Road area of West Green Neighbourhood together with some of the adjacent properties to the east of the A23 from Northgate ward in the proposed Langley Green and Manor Royal ward.

The Council understood that to achieve good levels of electoral equality it would be necessary to include an area from outside Langley Green Neighbourhood in the Langley Green and Manor Royal Ward. However, on balance, it considered it would be preferable to include The Orchards development instead. The Orchards has been included in the existing Langley Green Ward since it was built. The development is part of Ifield Neighbourhood and whilst the Council would have preferred that the development was included in Ifield Ward, it would be a less disruptive solution than moving the area around Windmill Court and Longmere Road which has always been included in West

Green Ward. This area is separated from Langley Green by a dual carriageway, whereas The Orchards is separated by just a single lane road (Ifield Avenue).

It was also noted that Burbeach Close in Bewbush has been included in Gossops Green Ward and it is recommended that it is included in Bewbush Ward as it is part of Bewbush Neighbourhood.

The Council's proposed alterations to the Local Government Boundary Commission's draft recommendations for Ifield Ward, Langley Green and Manor Royal Ward and Northgate and West Green Ward are set out in the attached map.


